The vigil is daily from 7 AM to 7 PM on the sidewalk in front of 540. **Are you registered to vote in the General Election on Tues. Nov. 4, 2014?** The NYS Voter Registration Form available at your Post Office states: "Mail or deliver this form at least 25 days before the election you want to vote in. Your county will notify you that you are registered to vote." If you did not recently received a card from the B.O.E. stating your polling location now is the time to inquire. **Absentee Ballots** are important for students and all homebound.
