Dear Defenders of Life:

I'm pro-life but.... I won't force my morals on anyone.

I'm pro-life but.... it's none of my business what others do.

I'm pro-life but.... if the couple can't afford a kid, then...

I'm pro-life, but abortion is okay

.... when the baby is going to die right away anyway

.... if the baby is going to be deformed, you know – not normal

.... if the mother was on crack or has HIV, stuff like that

.... in the 1st and 2nd trimester

.... in the 1st trimester

.... before 8 weeks

Like many of you, I hear these arguments and rationalizations again and again. Sometimes people stop by the pro-life table at street fairs and tell me they're pro-life; we get to talking and soon I realize they're really only pro-life in some circumstances or for some trimesters.

They all think they have a pro-life line in the sand. But then I ask them if they would stand at the door of an abortion business and ask each girl why she was having an abortion. Would they say to any girl: Oh no, that's not a good enough reason for me; sorry you have to have your baby. (No, they wouldn't.)

So, how do we answer the exceptions? What do we say to people who are "pro-life but...?"
