How Many Babies Die Through

Abortion? According to John Smeaton, Chief Executive of the Society for the Protection of the Unborn Child, a 'conservative' estimate compiled by 'leading researchers from both the pro-abortion and pro-life lobbies' of the number of abortions committed worldwide since 1966 is **2 billion**. Smeaton also acknowledges that, "The number of human embryos destroyed in the past 50 years by abortifacient birth control drugs and devices worldwide is simply incalculable," and the worldwide total number of babies killed as a consequence of IVF is unknown, though we know "in the UK alone, 2 million embryonic babies have been killed as a result of in vitro fertilization procedures since 1990." There are 7 billion human beings alive on the planet. That means over a **quarter** of the human race has been aborted over the past 50 years. **56 million** children have lost their lives to abortion in the United States since the 'legalization' of abortion in 1973.

Teen Pregnancies: In 2011, the teen pregnancy rate hit a record low of 52 pregnancies per 1,000 women aged 15-19. This rate represented a decline of more than 50% from the peak rate of 117 per 1,000 in 1990. In 2011, there were 13.5 abortions for every 1,000 women aged 15-19. This is the lowest rate since abortion was legalized in 1973, and 69% lower than the peak rate in 1988. At their peak decades ago, 1 in 3 pregnancies ended in abortion. Now 1 in 5 pregnancies in the US end in abortion. (Guttmacher Institute Report, June 2016)

*In 2015, "I Stand with PP" groups had financial flows amounting to \$678,000 with the AFL-CIO, \$174,000 with AFSCME, and \$2.6 million with the NEA. In 2014, \$1.5 million came from SEIU, which included a \$20,000 "sponsorship" to PP

*Between 2012 and 2013, PP reported SEIU as an independent contractor and paid the union \$1.8 million for "telemarketing" services. In a 2015 press release SEIU International's president, Mary Kay Henry stated, "We stand united with our allies at Planned Parenthood...efforts in Congress to de-fund Planned Parenthood...must be stopped."

*AFL-CIO president Richard Trumka said, "We support [Planned Parenthood's] core mission."

Just the Facts

*by 7 weeks, pain "sensory receptors appear in the perioral [mouth] area" (New England Journal of Medicine)

*by 10 weeks, "All components of the brain and spinal cord are formed, and nerves link the stem of the brain and the spinal cord to all tissues and organs of the body." (Encyclopedia of Human Biology)

*by 12 weeks, "Electrical activity of the nervous system is discernible" and "attempts to suckle" are observed "in utero and in aborted fetuses." (Encyclopedia of Human Biology)

*by 14 weeks, "limb movements...become coordinated." (Before We Are Born: Essentials of Embryology and Birth Defects)

*by 14 weeks, preborn humans exhibit conscious "motor planning" and "social behavior." (PLUS ONE)

*by 14 to 22 weeks, "a physiological fetal reaction to painful stimuli" occurs. (Fetal Diagnosis and Therapy)

*by 18 weeks, pain sensory receptors spread to "all cutaneous [skin] and mucous surfaces," and the cerebral cortex (the portion of the brain responsible for higher functions like reasoning and language) has the same number of nerve cells as a full-grown adult. (New England Journal of Medicine)

*by 18 to 20 weeks, the human fetus "elaborates pituitary-adrenal, sympatho-adrenal, and circulatory stress responses to physical insults." (Anesthesiology)

*by 20 weeks, the fetus "now sleeps and wakes and hears sounds." (American Medical Association Complete Medical Encyclopedia)



FEDERAL LEGISLATION

Last year, the US Supreme Court combined nine cases of religious non-profits vs the HHS abortifacient/sterilization/contraceptive Mandate into *Zubik v Burwell*. Many Court watchers saw this as a desire by SCOTUS to make a definitive, broad ruling on these types of cases. The pundits say the death of Justice Scalia dashed these hopes - (the Court deadlocked 4 - 4 on whether the Mandate violated the RFRA act).

Days after oral arguments in *Zubik*, the Court asked all parties to submit more briefs that suggested ways of meeting the HHS Mandate, and the plaintiffs objections. In the briefs, most plaintiffs said their objection was to "taking a positive action" that resulted in their employees getting the Mandated items, and the Government admitted there are ways to do that without the plaintiffs taking action.

On May 16, the Justices unanimously remanded all nine cases back to the lower courts, instructing them: '...to find tweaks in the HHS mandate to eliminate any faith-based concerns "while...ensuring that the affected women receive contraceptive coverage seamlessly.'" All prior fines are cancelled and lower court rulings vacated.

Many analysts said this ruling was a "punt," yet it does avoid a "tie" outcome, where conflicting lower court rulings would continue in force. Prof. Mike McConnell said he never heard an appellate court say "...we'd prefer not to decide the case. Go back to the lower courts..." Pro-abortion media said "Ruling should clear the way to free birth control for women with religious employers." (Source: *LA Times*). Pres. Obama was pleased with the outcome. Pundits at SCOTUSBLOG wondered how anyone could have objected to simply signing a paper that allowed the "sinful" items, when the insurer provided them and the Government paid for them. The *Little Sisters of the Poor*, who were part of the case, were not mentioned once by the *NY Times* in its 1283 word story on the Court's outcome.

The Senate companion to the *Conscience Protection Act of 2016*, **S.2927**, was introduced May 12.

The *Frank Wolf International Religious Freedom Act*, **HR 1150**, passed the House 5/16, (voice vote), Rep. King co-sponsored. It upgrades the 1998 I. R. F. A..

The U.S. Commission on International Religious Freedom (USCIRF) lists "countries of particular concern," - Myanmar, China, Eritrea, Iran, North Korea, Saudi Arabia, Sudan, Turkmenistan and Uzbekistan. The USCIRF 2016 annual report says Egypt, Vietnam, Iraq, Nigeria, Pakistan, Syria and Tajikistan should be added.

Two new anti-life threats to Conscience Protection are: The *Do No Harm Act*, **HR.5272**, would forbid religious objection to performing any medical service. The *Access to Birth Control Act*, **S.2960**, says pharmacies must provide, or refer women for, all requested 'birth control'.

NOTE: *LICL objects to ObamaCare because parts in it include abortion coverage & abortifacient/sterilization / contraception coverage at taxpayer expense, and direct or implicit limiting of care to vulnerable populations such as sick newborns and the terminally ill."*

On May 13, the HHS Dept. issued the final ruling on ObamaCare Section 1557. It says all healthcare providers and insurers getting Federal funds must do abortions and gender changes. The rule doesn't have its own religious exemption, but claims to NOT overturn current religious exemptions.

Three Churches in CA are still fighting the 2014 rule by the *CA Dept. of Managed Health Care* that abortion is "basic health care", and *must* be covered by *all* policies. This appears to violate the federal Weldon Amndt., that bans discrimination against insurers who don't cover abortions, and cuts federal money to the violating state. But Congress has yet to act against California. (Note: CA Law doesn't require churches to cover contraceptives!)

Indiana passed a law in March requiring the remains of aborted babies be buried or cremated. It also bans the sale/transfer of their parts. In late May 2016, Indiana U filed a suit, claiming the ban would be "catastrophic."

ACTION ITEMS - Tell your Federal Reps. to oppose *Do No Harm Act*. Urge your NYS Reps. to vote against A10059 and any NYS Senate companion bill related to Assisted Suicide/Euthanasia.

NEW YORK STATE LEGISLATION

On 6/7/16, the NYS Assembly passed A06221 by a vote of 92-50. This bill states, "The state shall not deny a woman's right to obtain an abortion as established by the United States Supreme Court in the decision *Roe v Wade*...Notwithstanding any law to the contrary, New York protects a woman's right to terminate a pregnancy within twenty-four weeks from commencement of her pregnancy or when necessary to protect a woman's life or health as determined by a licensed physician." The bill now moves to the NYS Senate (S04432). According to Syracuse.com, the Senate is unlikely to pass it.

On 5/10/16, the NYS Assembly Health Committee passed A10059 - Medical Aid in Dying Act - by a vote of 14-11. A10059 combines two bills from January 2015: A5261, Patient Self-Determination Act and its companion Senate bill S5814, Patient Self-Determination at the End of Life Act, with A2129, New York Death with Dignity Act and its companion Senate bill S3685, New York End of Life Options Act. Lisa Bourne reported at *LifeSiteNews.com* on 5/10/16 that the NYS bill is modeled after Oregon's Death with Dignity Act. Introduction of this bill followed on the heels of an appeals court ruling the prior week which found there was no right to assisted suicide in the state. Plaintiffs in the case have indicated they will appeal to the NY Supreme Court.

Planned Parenthood, David Daleiden and the House Investigation Panel



The Wednesday, June 1st STOPP Report announced that “recent court filings in the Houston-area civil and criminal cases against undercover journalist David Daleiden reveal that the Harris County District Attorney’s office illegally shared evidence with Planned Parenthood. Planned Parenthood Gulf Coast attorney Josh Schaffer admitted in a sworn declaration that the DA’s office shared materials and information with Planned Parenthood, even after the Texas Attorney General’s office had forbidden them from doing so. The declaration was included as part of the DA’s office response to David Daleiden’s motion to quash the indictment against him, alleging prosecutorial misconduct. Under oath, Schaffer admitted that he and Assistant District Attorney Sunni Mitchell attempted to do an end-run around the Texas Attorney General’s directive to Mitchell to not share raw video footage with Planned Parenthood: “I was told that the Attorney General’s office agreed to give it to the Harris County District Attorney’s office on the condition that they not give it to Planned Parenthood. Mitchell told me that she would try to obtain the footage by other means.” In 2013, Mitchell was responsible for a Grand Jury that refused to indict Houston’s late-term abortionist Douglas Karpen. This was despite photographs and eyewitness testimony that implicated Karpen in illegal late-term abortions and homicide of born-alive infants, similar to Philadelphia’s notoriously convicted Kermit Gosnell.”

Daleiden’s attorney Peter Breen stated, “The recent filings by the Harris County District Attorney confirm that the DA shared confidential documents and information with abortion provider Planned Parenthood, colluding with it in the prosecution of David Daleiden. These filings also include evidence that appears to show that the DA’s office worked with Planned Parenthood Gulf Coast to undermine the Texas Attorney General’s independent investigation of that abortion provider. The conduct of Harris County prosecutors in this case is outrageous and illegal. We look forward to pressing our motion to quash this indictment in court.”

Claire Chretien reported at LifeSiteNews on June 1st, “The Congressional panel investigating the fetal tissue research company StemExpress, which the Center for Medical Progress [David Daleiden] exposed in its groundbreaking undercover videos about fetal body parts trafficking, found that StemExpress and the abortion centers with which it contracted violated federal patient privacy and informed consent regulations. In 2 letters to the US Department of Health and Human Services (HHS), Select Investigative Panel on Infant Lives Chair Rep. Marsha Blackburn detailed the panel’s findings on StemExpress’s cozy relationships with abortion facilities. The panel found that StemExpress employees had access to confidential patient health information – which they had no medically necessary reason to see and the abortion centers had no reason to

disclose – in order to streamline their workflow and thus maximize profits.

“According to the Panel, StemExpress was allowed to use this confidential information to be matched up with patients whose aborted babies matched their fetal tissue demands. The letters indicate that StemExpress employees were working alongside abortion workers in ways that appear to conflict with regulations related to research on human subjects and federal privacy law... Research on human subjects must be approved by a valid Institutional Review Board (IRB) to ensure that the research is ethical and safe. StemExpress didn’t follow these procedures when obtaining informed consent from abortion clinic patients, Blackburn wrote. Blackburn’s letter said it’s unclear whether patients consented to donating tissue from their aborted infants before or after the abortion procedures took place and the manner in which patient consent was obtained raises ‘serious concerns’ about whether patients were coerced or unduly influenced into donating fetal tissue. The IRB that StemExpress used, BioMed IRB, was unable to produce to the Panel any of the records it is required by law to keep, such as copies of all research proposals reviewed, possible scientific evaluations of the proposals, approved sample consent documents, investigator’s progress reports, and minutes of IRB meetings... Blackburn’s letter stated, “The key to understanding the HIPAA and consent violations that we’ve referred to HHS is that there’s a business contract between StemExpress and the abortion clinics under which both sides make a profit from the baby body parts inside the young woman’s womb. The contract changes the way both entities view the young woman: her baby is now a profit center. This betrayal of a young woman’s trust should disgust us all. It takes financial advantage, obtains consent through coercion, and deceives the woman, all in violation of federal privacy laws.” Each time an abortion clinic employee shared with a StemExpress employee a patient’s confidential records, both of them were violating federal privacy law. It does not appear that any patients authorized the abortion facilities to share their private records with StemExpress.”

Ben Johnson reported at LifeSiteNews.com on May 31st that California state legislators have introduced Assembly Bill 1671, which would make it illegal to secretly videotape any ‘healthcare provider’, including abortionists. This includes, but is not limited to, videos, still photographs, blogs, video blogs, podcasts, instant and text messages, email, online services or accounts, or Internet Web site profiles or locations. Planned Parenthood is lobbying in support of this bill. Lila Rose of Live Action commented, “For years, undercover journalists have documented Planned Parenthood employees covering up for sex traffickers, failing to report child sexual abusers, and trafficking in baby body parts. Rather than be more transparent to the public, Planned Parenthood wants to make it a crime for the media to publish evidence that it might be doing something illegal.”
