### **Pro-Life Resource List**

The April issue of *Life News* published a list of local pro-life pregnancy resources and post-abortion healing contacts. In an effort to make this information more widely known, the Long Island Coalition for Life has sent copies of the resource list to more than 1400 churches and synagogues in Nassau & Suffolk Counties. We hope the list will be used for pastoral care and shared beyond the congregations. Likewise, the LICL Educational Trust sent the resource list to 14,000 households in Nassau & 18,000 in Suffolk Counties with women between the ages of 18-20. Awareness of help for untimely pregnancies may divert parents from a life-ending abortion decision and make abortion unwanted, **not** their preborn children. ### **Disturbing Developments**

LifeNews.com carried an opinion piece on May 28 by Bradley Mattes, president of Life Issues Institute. Mattes warned that the Biden administration “wasted no time using your tax dollars to fund so-called medicine that is sinister, unethical, and deadly...with the encouragement of the Biden administration, the International Society for Stem Cell Research (ISSCR) has announced a new protocol that impacts the way they experiment on human embryos.” In the past, the ‘14-day rule’ limited “experiments” on human embryos to 14 days. After that, the embryos had to be destroyed – killed. The ISSCR “jettison[ed] the two-week policy and replace[d] it with no limit. The result is horrific “baby in a bottle” experiments on tiny babies with fully functioning hearts, developing brains, eyes, and ears.” In the latest effort to use euphemisms in an attempt to minimize the outrage many will feel learning of this, “these tiny human beings have been downgraded semantically to “ethically sensitive research material” in an effort to dehumanize their victims.”

Matte then referred to an article by Ingrid Skop and Senator Cindy Hyde-Smith in the Washington Examiner on May 7 which reported that the Food and Drug Administration “recently suspended mifepristone’s risk evaluation and mitigation strategy enforcement, making chemical abortion pills available without in-person medical consultation and abandoning its responsibility to protect women and girls from these dangerous drugs. Acting under cover of COVID-19 precaution, the FDA is diverting women to a riskier abortion procedure, even though the foreseeable harms would far outweigh any supposed benefit. The benefits of chemical abortion for abortion providers? It is lucrative and requires few skills. The benefits for a woman? There are none. Chemical abortion takes much longer, causes more pain and bleeding, and often results in emotional trauma from visualization of a woman’s deceased child...Additionally, the risk of complications is four times greater with chemical abortion compared to surgical abortion, affecting as many as one out of five women. These complications can be serious or even fatal for women without immediate access to emergency medical care.”

The third development that Matte reported on was Biden’s “reversal of a Trump policy [which] unleashed your tax dollars to empower the National Institutes of Health (NIH) to fund experimentation using the body parts of aborted babies purchased from the abortion industry. The NIH funded research at the University of Pittsburgh in which “the scalps of five-month-old unborn babies [were] grafted onto the backs of mice...The NIH then rubbed salt into this wound by announcing it would no longer convene an Ethics Advisory Board to review proposals involving fetal body parts.”

Mattes concluded by noting that since the beginning of this year, 549 bills in 47 states have been introduced to protect the unborn. He said, “It’s time Congress took our lead and grew the moral spine to bring Joe Biden’s trifecta of inhumane medical practices to an end.”



## FEDERAL LEGISLATION

The new budget submitted by the Biden Administration lacks the “Hyde Amendment.” This actually is a group of about 18 pro-life rules added annually to each budget. These rules ban tax monies for abortions abroad and at home, as well as in several programs,

with the usual exceptions. They also protect those receiving funds from coercion.

Four months into the Biden Administration and it has already sent **twenty times more money to the abortion industry** than the Obama Administration at the same point. National RTL says a proposed HHS “gimmick” would allow *Title X* to fund abortions and force *Title X* recipients to counsel and refer clients for abortions. Both practices are currently illegal.

Under the Trump Administration’s **Protect Life Rule**, Planned Parenthood and others no longer took *Title X* funds. The current Administration says that led to over 840,000 (mostly poor) woman losing services. Yet PP’s 2019 report shows no drop in clients.

A Senate Committee called officials to ask how **PP illegally got \$17.6M from the Paycheck Protection Program**. Secretary Yellen did not show up, and Small Business Administration head Isabel Guzman did not answer questions from Sen. Rand Paul.

When Rep. Crenshaw returns from surgery, he will sign the Discharge Petition asking for a vote on [HR.619], the **Born Alive Act**. Thus, all 212 House GOP members will have signed, but 218 signatures are needed to enact.

Congress has introduced the **Stop Forced Organ Harvesting Act**, [HR.1592/S.602]. This bill combats international trafficking in persons to remove organs, promotes voluntary organ donation systems internationally, and promotes the dignity and security of human life in accordance with the Universal Declaration of Human Rights.

The ISSCR (stem cell scientists) stated the US should increase the number of days an embryo can be grown *in vitro* from 14 to 40, end the Aderholt Amendment (banning 3-parent embryos), and loosen regulations on mixed human-animal embryos. The **Human-Animal Chimera Prohibition Act** (HR.3542/ S.1800) was introduced. The Senate voted NO, 49-48, on 5/27.

The Supreme Court will hear **Dobbs v Jackson**, Mississippi’s 15-week abortion ban, this fall. Some pundits say pre-viability abortion restrictions are the question, others say the Court could rule that *Roe* and *Casey* were wrongly decided.

Eighty-two House GOP members have asked the Supreme Court to overturn the 8<sup>th</sup> Circuit and allow Arkansas’ law that bans abortion solely for a diagnosis of Down Syndrome



## NEW YORK STATE LEGISLATION

**A.5499/S.470** would create a state commission to “study” and harass pregnancy resource

centers. These centers, which save so many lives by offering help and support to pregnant mothers, have been the target of pro-abortion forces before. They want to shut them down. Their claim this time is that pregnancy resource centers do not offer “all options” (of course they don’t

advocate the “option” of killing an innocent child!) and that they don’t always have physicians and nurses on staff, so they are not “comprehensive” medical clinics and shouldn’t exist. **To prevent this harassment of the heroes at pregnancy resource centers who are helping mothers and saving lives, this bill must be defeated!** See the links below to call AND email your legislators.

**A.204/ S.4685** attacks innocent lives at the other end of the continuum: elderly New Yorkers and those with disabilities. It would allow doctors to invoke “medical futility” and override the expressed wishes of a patient that he or she WANTS life-saving resuscitation (ignoring the right of the patient “choice” and autonomy). This affects both DNRs and Surrogate’s consent. Thousands of elderly New Yorkers just paid a tragic price for state policies in nursing homes. Their wishes and medical needs should not be denied again! Please call AND email your legislators and ask them to oppose this violation of fundamental rights of patients.

**A.382/S.5535** Human Composting Bill. This bill would allow New Yorkers to end their earthly existence as “natural fertilizer.” Many are opposed to this stating it violates the reverence and respect due the body of a deceased person.

**AlbanyUpdate** podcast#1675 says a group of churches and organizations has filed in the US Supreme Court to fight the NY law mandating all medical insurance must cover abortion.

### **OTHER NEWS:**

\*A survey by *Let Them Live* says 70% of women who consider abortion are driven by financial worries.

\*Regarding the new Texas ‘Heartbeat law’, pro-abortionists are most concerned that it allows anyone (except rapists) to bring suit against a doctor who violates the law.

\*In late 2015, a New Mexico late-term abortuary changed its consent form, making it clear that if the mother checked YES, her baby’s body would be “donated” for medical research. Donations dropped dramatically.

### “Reject Eugenics, and Instead Build a Civilization of Love”



Fr. Shenan J. Bouquet posted an article with the title above on HLI.org on 5/31/21. In 2014 Richard Dawkins was asked on Twitter what a woman should do if she found out she was pregnant with a child with Down syndrome. He replied, “Abort it and try again. It would be immoral to bring it into the world if you have the choice.” He never apologized or deleted the Tweet. In May 2021, Brendan O’Connor, an Irish radio host who has a daughter with Down syndrome, asked Dawkins, “How do you think it is immoral to bring someone with Down syndrome into the world?” Dawkins agreed that those who have a child with Down syndrome do love and cherish their child, “but before it’s born, the vast number of people take an amniocentesis and [if the child] is diagnosed with Down syndrome, as a matter of fact, do abort it.” O’Connor agreed that statistics show that most children diagnosed with Down’s are aborted, but asked again, “Why is it immoral not to abort?” Dawkins replied, “...given that the amount of suffering in the world probably does not go down – probably does go up – compared to having a child who doesn’t have Down syndrome, then that’s what I meant.”

O’Connor then asked how Dawkins knew that suffering increased when a Down child was born. Dawkins – a world-famous “intellectual” - gave this shocking reply, “It seems to me to be plausible that...if a child has any kind of disability, then you probably would increase the amount of happiness in the world more by having another child instead.” Fr. Bouquet reflected that if Dawkins ever took the time to actually speak to those with Down’s and their caregivers, he would find that “there is a good argument that the exact *opposite* is true. The fact is people with Down’s consistently rank themselves as among the happiest people on earth! Their caregivers too, while acknowledging the challenges associated with caring for someone with the condition, consistently say that their lives have been enriched by having a child with Down’s.”

J.D. Flynn, a journalist who adopted two children with Down’s, wrote an open letter after Dawkins’ 2014 Tweet. Flynn wrote, “They’re delightful children, They’re beautiful. They’re happy. One is a cancer survivor, twice-over. I found that in the hospital, as she underwent chemotherapy and we suffered through agony and exhaustion, our daughter Pia was more focused on

befriending nurses and stealing stethoscopes. They suffer, my children, but in the context of irrepressible joy. I wonder, if you spent some time with them, whether you’d feel the same way about suffering, about happiness, about personal dignity. I wonder, if you danced with them in the kitchen, whether you’d think abortion was in their best interest. I wonder, if you played games with them, or shared a joke with them, whether you’d find some worth in their existence...I don’t want you to come over for a debate. I don’t want to condemn you. I want you to experience the joy of children with Down syndrome. I want your heart to be moved to joy as well.”

A study done in 2011 by Skotko, Levine, and Goldstein found that 99% of those with Down syndrome who were surveyed were “happy” with their lives. Another study in 2011 by the same authors found that 99% of the parents of children with Down’s who were surveyed love their child, 97% were proud of them, and 79% felt their outlook on life was more positive because of their child. Fr. Bouquet notes that scientists should “first look for empirical evidence to support a claim. Dawkins, however, has never bothered to actually investigate whether or not it is true that Down syndrome somehow reduces the amount of happiness in the world. And yet, this has not stopped him from advocating the wholesale, industrial elimination of people with Down’s.”

Fr. Bouquet refers to a speech Pope Benedict XVI gave in 2009. The Pope spoke of the rise of a “new eugenics.” Whereas old eugenics targeted people based on race and class, new eugenics “give[s] priority to functional ability, efficiency, perfection and physical beauty to the detriment of life’s other dimensions which are deemed unworthy. The respect that is due to every human being, even bearing a developmental defect or genetic disease that might manifest itself during life, is thus weakened while children whose life is considered not worth living are penalized from the moment of conception...What must be strongly reaffirmed is the equal dignity of every human being...A person’s biological, mental, and cultural development or state of health must never become a discriminatory factor. On the contrary, it is necessary to consolidate the culture of acceptance and love showing real solidarity toward those who suffer. It must break down the barriers that society often builds by discriminating against those who are disabled or affected by pathologies, or, worse, even reaching the selection and rejection of life in the name of an abstract ideal of health and physical perfection.”

Fr. Bouquet concludes, “Richard Dawkins’ cold utilitarianism simply has no room for the kind of selfless love and joy embodied by [families with children with Down’s]. I hope you will join me in praying for his conversion of heart (and for all who share his view). My prayer is that one day soon, he will use his considerable public platform to advocate on behalf of the disabled, the unborn, and the dignity of all people.”
