## FEDERAL LEGISLATION

In recent decades, the US Supreme Court has been releasing its decisions on the most contentious cases in (late) June. This year, pro-lifers await rulings in four cases.

They are:

- *McCullen v. Coakley* challenges a MA law which sets a 35 foot "bubble zone" around abortion facilities.

- *Susan B. Anthony List, et al., v. Driehaus, et al.* SBA said ObamaCare pays for abortions, and was charged under the Ohio False Statement (campaign) Law.

♦ *Conestoga Wood Specialties Corp. v. Sebelius* and *Sebelius v. Hobby Lobby*. The HHS Department says most employer provided Health Insurance must cover contraceptives, sterilization and possible abortifacients. Both companies seek a conscience rights exemption.

No cases of religious groups vs the HHS Mandate have gotten to the Supreme Court. One such case working its way through lower courts is *Catholic Archdiocese of NY v. Sebelius*. Rockville Centre Diocese is part of this case.

Latest action - The federal government has challenged Judge Cogan's injunction protecting the Archdiocese from HHS Mandate.

Note: The LICL objects to Obamacare because of the parts in it that include abortion coverage at taxpayer expense, abortifacient contraception coverage at taxpayer expense, and direct or implicit limiting of care to vulnerable populations such as sick newborns and terminally ill.

The American Family Assoc. released the following on 4/4/14: "...the IRS...put off implementing regulations proposed by the Obama administration that were intended to shut down distribution of voter guides and legislative scorecards, holding get-out-the-vote campaigns and even voter registration activities by...(tax exempt) groups...."

IRS Commissioner John Koskinen recently issued this Statement: "During the comment period, which ended in February, we received more than 150,000 comments. That's a record for an IRS rulemaking comment period.... It's going to take us a while to sort through all those comments, hold a public hearing, possibly re-propose a draft regulation and get more public comments...it is unlikely we will be able to complete this process before the end of the year."

On 4/16/14, *Washington Post* reported that Koskinen said the IRS will seek to clarify what "candidate -related political activity" means, so as to better regulate it.

ACTION ALERT: HR.863, a bill to study whether to create a 'National Women's History Museum', has not yet passed the House. It has a study board full of pro-abortionists. Tell your House member to vote *against* HR.863, unless it is amended to ban anti-life slanting of exhibits.

## NEW YORK STATE LEGISLATION

**Continue to watch and take every opportunity to Oppose Abortion Expansion (to make abortion legal in NYS through all nine months) which may come to a vote in the Senate at any time.** As of 5/6/14 there has not been a vote on abortion expansion by the full Senate in 2014. The Assembly passed the Women's Equality Act (WEA) bill No. A.08070, by a vote of 88-43 on 1/27/14.

All NYS pro-life groups are on guard and working to stop abortion expansion as part of Gov. Cuomo's 10-point "Women's Equality Act" or as standalone legislation. On 4/7, the NYSRTL Committee, Inc. cautioned: "Unlike last year, the battle is being conducted quietly. It appears Gov. Cuomo does not want a lot of attention to this issue because this is an election year."

**Pro-life won a small victory on 5/6/14** when the Senate Health Committee voted to prevent S.438, the extreme abortion bill introduced in 2013 by Sen. Stewart-Cousins, from moving to the full Senate. Thank you to all who contacted Senators to oppose. Health Committee members voting pro-life are Senators Ball, Farley, Golden, Hannon, Larkin, Martins, Seward and Young.

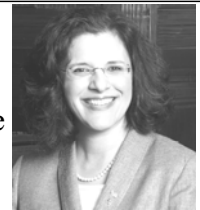

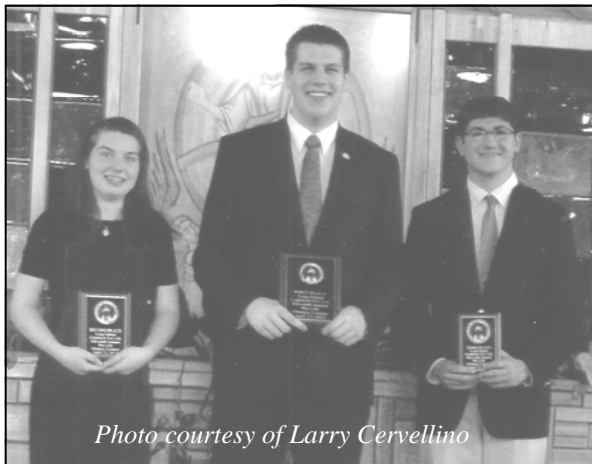
**You're Invited!**


