## FEDERAL LEGISLATION

The *Conscience Protection Act of 2016* [HR.4828], is in sad need of cosponsors. It bans the Fed., State & Local governments that get federal money, from discriminating against, or punishing medical providers who don't perform, offer coverage for, or pay for abortions.

The *Prenatal Nondiscrimination Act* (PRENDA) [S.48/ HR.4924] has been reintroduced. It sets criminal penalties for anyone who knowingly attempts or performs a sex-selection abortion. The Charlotte Lozier Inst., (April 14 House committee hearing), said evidence from census records indicate Asian-Pacific immigrants to the U.S. may be obtaining sex selection abortions; a known practice in China, India and Korea. There are also increasing male over female birth ratios in Europe.

The *STOP Organ Trafficking Act* [H.R.3694] would ban the forced removal of organs from living children, regardless of the child's level of brain activity.

All of the three bills featured above are in committee. Last month's Federal column reported the unusual SCOTUS request for more briefs, after hearing the *Zubik v Burwell* case (Little Sisters, Geneva Col., Priests for Life, etc). Filed in mid-April, the Administration brief, on page 14, admits there are ways to provide the government mandated abortifacient/sterilization/contraceptive coverage to the employees of religious based institutions, with no direct involvement of the employer. (Example: In Missouri, employers can get an insurance plan without objectionable coverages. The insurer must then notify those employees of their ability to request a separate policy, to cover those services.)

The *ACLU sued Trinity Health Corp* (86 hospitals), claiming harm from the hospital system's pro-life position because their doctors refused to perform abortions on five women who suffered preterm complications. In its dismissal order, the US District Court for the Eastern District of Michigan, Southern Division, called the ACLU's claims of harm 'dubious', explaining that they haven't satisfied the legal requirements to demonstrate such harm and therefore bring a lawsuit. The court additionally found that, for those reasons and others, the lawsuit is 'not ripe for review', meaning nothing has happened to warrant court action. (Lifenews.com 4/11/16)

On Apr 19, the Obama Administration sent letters to all 50 states, saying a state that ends Medicaid funding of Planned Parenthood is breaking federal law. (Medicaid requires states to match federal funds). States say they can control how their tax-money is spent. It is speculated the federal government may sue the ten states that have now defunded PP.

98 House members sent a letter to Speaker Paul Ryan, asking him to end the Select Investigative Panel's probe into covert video allegations that PP is selling "aborted baby parts." Cong. Israel, Meeks & Rice signed the letter.

*implicit limiting of care to vulnerable populations such as sick newborns and terminally ill!"*

The House Ways & Means Comm. wants to know where HHS got \$1.3B for ObamaCare's 'Basic Health Program'. The Program can pay for abortions due to rape, incest or to save the mother's life. Insurers warn ObamaCare is "unsustainable," and the nation faces a shortage of one million doctors by 2025.

In 2014, the group *Freedom from Religion* sued the IRS, demanding it enforce the Johnson Amendment which bans tax-exempt orgns. from endorsing candidates for election. In response, the IRS wrote procedures for when it would initiate 'church investigations', but kept the document secret. Despite a FOIA request, and further legal action by Judicial Watch and Alliance Defending Freedom, the IRS has released only a fraction of the requested papers.

**ACTION ITEM-** Ask your House member, and our NY Senators, to cosponsor and vote YES on the *Prenatal Nondiscrimination Act* (PRENDA) [HR.4924/S.48]. Sex-selection abortions are the true "War on Women".

## NEW YORK STATE LEGISLATION

The NYS Legislature will be meeting in May & June. Please be aware that the

Bonacic and Savino bills (Physician-Assisted Suicide) are active. These 2 senators have submitted their bills to the Health Committee chaired by Sen. Kemp Hannon of Nassau County. The Stewart-Cousins bill (Women's Equality Agenda) has also been resubmitted. This abortion expansion bill would make abortion laws stronger than Roe v Wade in NYS. This bill will be sent to the Finance Comm.

The status of these bills can be checked on the NYS Catholic Conference website ([www.nyscatholic.org](http://www.nyscatholic.org)). To express opposition to these bills, contact Sen. Hannon at 516-739-1700, Sen. Bonacic (Sullivan Co.) at 845-344-3311, Sen. Savino (Staten Island) at 718-727-9406, and Sen. Stewart-Cousins (Yonkers) at 914-423-4031.

It is imperative to promote the prolife position in the NYS Senate, since Kaminsky (pro-abortion) won the seat formerly held by Dean Skelos in Nassau Co. There is now a razor thin majority in the NYS Senate, as (pro-life) Sen. Felder (D-Brooklyn) caucuses with Republicans.

Thank you for giving me this opportunity to share my heart. Being a huge supporter of women's rights myself, I noticed the activism for abortion to be heavily laden with some obvious flaws. Before I get into them, I want to touch on what our identity as women means. Men are completely equal to us, but only one of us owns the God given "superpower" to bring life onto this earth. But, where are all my women hiding in this crucial time of American history? Where, sadly, twenty-one percent of all pregnancies end in abortion. The louder that we scream "my body my rights!" the further it drowns out the baby's inaudible voice that says, "my life my rights."

But this should not be. As ladies, we need to step up and make a name for ourselves by becoming the forerunners that we all are. Forerunners, what women have always been from the foundations of the earth; the founders, originators, overseers, and mothers. I mean, did we not carry the founding fathers in our wombs for 9

Cervical damage is one of the leading causes of life-long complications following an abortion. This damage done to the cervix increases the future risks of miscarriage, premature birth, and labor complications by 300-500 percent. A researcher also found that 66% of the teenagers who aborted their first pregnancy experienced miscarriages of their second "wanted" pregnancies. When rounded up, 100,000 babies are lost due to the complications previous abortions have caused. Finally, women who have had abortions face a 58 percent greater risk of dying during a later pregnancy, and chances of tubal pregnancies are increased by 160%. The procedure of abortion itself also will interrupt natural changes in the breast, leaving millions of cells at high risk for breast cancer.

I invite you to have a conversation with virtually any woman who has undergone an abortion. You may find such a woman alone, pouring another drink, trapped in silence and shame. When these ladies aborted, they were probably influenced by that "inspiring" mantra that says, "Nobody can dictate what I do with my body." They are now searching for hope in all the wrong places to forget the guilt of knowing that there should be one more person in their life.

Let us not forget that the unborn are not alone in the history of the deemed unvalued. Remember, the blacks can relate to them well as they were once deemed by the Supreme Court as non-human with no rights. The only difference is they got to keep their lives. The Fascists, Nazis, and Communists also thought murder was okay.

As always, Scripture seals the deal. God said through the prophet Jeremiah, "Before I formed you in your mother's womb I knew you." Even so, you don't need religion to be against abortion, just a healthy conscience and some kindness.
