## **YOUR NEW YORK STATE SENATOR MUST HEAR THIS MESSAGE: Please work to STOP EXPANSION OF ABORTION THROUGH THE NINTH MONTH OF PREGNANCY IN N.Y.S.**



The N.Y.S. Assembly passed abortion expansion, on January 27, 2014, as part of the 10-point Women's Equality Act. We appeal to all N.Y.S. Senators to stop abortion expansion.

On February 11, 2014 a copy of the following letter from the Long Island Coalition for Life was presented at the Albany office of each legislator.

### **Dear New York State Legislator:**

We at the Long Island Coalition for Life are asking you to **oppose any part of the Women's Equality Act that would expand abortion under New York State law**. The abortion expansion part of the Women's Equality Act would enshrine, in New York State Law: abortion on demand through all nine months of pregnancy; allow post-viability abortions to be performed on an outpatient basis in clinics; allow any "health care practitioner" to perform an abortion which could mean a non-physician; could eliminate conscience protection for religious hospitals that refuse to perform abortions. The abortion provision of the Women's Equality Act would make abortion a "fundamental right." This provision would make it almost impossible to do what thirty-seven states have already done, for example, pass laws that require parental consent or notification for minors seeking abortions.

If we combine modern ultrasound technology, which clearly shows a human being in a woman's womb, with our most important founding document, the Declaration of Independence, which states all human beings have an "unalienable right to life," then the killing of over fifty-six million preborn babies since Roe v. Wade was handed down in 1973 is a gross violation of our most fundamental moral and political beliefs.

The worst crimes in human history have been committed by political leaders who have dehumanized a particular group of human beings. Abortion, genocide, and slavery all come from the same poison well, the end justifies any means and might makes right.

Don't let the dehumanization of the pre-born baby be your legacy as a public servant. Please oppose abortion expansion in New York State law.

**Patricia Heaton's Gutsy Tweet About Margaret Sanger and Black Abortions**

## FEDERAL LEGISLATION

As of 3/6/14, there has been no further movement on any of the pro-life bills in Congress, such as the *Title X Abortion, Provider Prohibition Act* [HR.61, HR. 217, S.135], the *Prenatal Nondiscrimination Act (PRENDA) of 2013* [HR.447/S.138], the *Child Interstate Abortion Notification Act (CIANA)* [HR.732/S.369], the *Health Care Conscience Rights Act* [HR.940/S.1204], the *No Taxpayer Funding for Abortion Act* [HR.7, S.142/S.946], and the *Pain Capable Unborn Child Protection Act* [HR.1797/S.1670]. HR.7 & HR.1797 have passed the House, and await Senate action.

The proposed budget sent to Congress on 3/4/14 includes \$286.5M in *Title X* funds for Planned Parenthood, down a little from last year. But it has \$15B, (over 10 years), in ObamaCare funds, loosely defined for 'health services & training'. Some of this money could go, directly or indirectly, for abortions. [Source: *lifeneews.com*, 3/4/14.]

**NOTE:** *LICL is against the anti-life parts of ObamaCare, but takes no position on the entire bill.* ObamaCare's *Independent Payment Advisory Board*, (called a 'death panel' by some) should have made its first recommendations this year, but it has yet to be fully staffed. HHS Secretary can recommend in its place.

On 2/12/14, the Federal government stated its intention to appeal Judge Cogan's 12/16/13 ruling in *Catholic Arch-diocese of New York v. Sebelius* (DRVC is a part of this case). The ruling protected Catholic Health Services of LI from the HHS Contraceptive/Sterilization/Abortifacient Mandate. As of 3/5/14, the appeal has not yet been filed. The most recent delay in ObamaCare, announced on 3/3/14, does not affect the HHS Mandate.

The Supreme Court heard the cases of *Hobby Lobby & Conestoga Wood v. the HHS Mandate* on 3/25/14. Expect a decision on these for-profit companies in late June.

**ACTION ALERT:** Tell your House of Representative Member -- vote *YES* on HR.23, the *Sanctity of Human Life Act*. It declares that

- 1) All humans have a Constitutional Right to Life.
- 2) Human life begins at fertilization, as does full Personhood.
- 3) Federal & State gov't's have the authority to protect all human life.

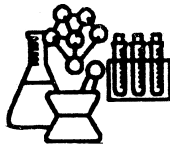

## HEALTH & SCIENCE

### Pro-Life Laws Work



On February 3rd, Rachel K. Jones and Jenna Jerman of the Guttmacher Institute (a pro-abortion research group), released a report titled "Abortion Incidence and Service Availability in the United States, 2011," which stated the abortion rate dropped to its lowest level since 1973. The abortion rate in 2011 was 16.9 abortions per 1,000 women aged 15-44. The peak rate was in 1981, 29.3 per 1,000 women. The lowest rate was in 1973, 16.3 per 1,000 women. The number of surgical abortions in 2011 was just over 1.1 million. The Guttmacher Institute is a former research affiliate of Planned Parenthood, the largest abortion provider in the United States, and is described by the Washington Post as a "pro-abortion-rights think tank".

Richard Doerflinger, Associate Dir. of the Secretariat of Pro-Life Activities, USCCB, states, "because it is trusted by abortion providers and gets its information directly from them, Guttmacher's abortion data are often more complete than those gathered by the federal government from state health departments. But the group also has an ideological agenda. So as we welcome its data, we need to be cautious of its 'spin'. That spin is in full gear. Based on little evidence, the authors dismiss the possibility that the decline in abortion could be due largely to the passage of pro-life state laws. (Even here, though, they make exceptions - conceding that abortion rates may be reduced by bans on public abortion funding, and by laws requiring women seeking an abortion to make two visits to a clinic separated by a 24-hour waiting period.) They also say the 13% drop in abortions from 2008 to 2011 is probably not due to a further decline in abortion providers, because their numbers are almost unchanged. Instead, they attribute the decline to wider use of contraception, and especially to increased use of 'LARCs' (long-acting reversible contraceptives) like the IUD and hormonal implants. These, say Guttmacher, are less prone than other contraceptives to 'user error'."

Doerflinger notes that LARCs "suppress fertility for 3-10 years and can be removed only with the help of a doctor...numerous studies suggest that contraceptive programs don't substantially reduce unintended pregnancies or abortions. 'Reproductive rights' advocates are aware of these findings. That is why, in their frustration, they are increasingly pushing semi-permanent methods which are less subject to what some call 'user motivation'...it has long been known that women using contraception may reduce the likelihood of pregnancy, but the likelihood increases that any pregnancy that does occur will be ended by abortion. Statisticians call this an increase in the 'abortion ratio', the number of abortions per hundred pregnancies (excluding miscarriages)...Thus, if wider or more consistent use of contraception were the chief reason for the abortion decline, we would see a reduction in total pregnancies (that is, a reduction in the sum total of abortions plus births), but not as much of a reduction in abortions. Births would decline more than abortions do. Yet between 2008 and 2011, the opposite happened: Births declined by only 9%, while abortions declined...by 13%. Not only the abortion rate, but also the abortion ratio, has

dropped to its lowest level in at least two decades. 4 out of 5 women who do become pregnant are letting their babies live. That can't be due to contraception."

Doerflinger also states that there has been a "sharp decline" in the number of teen abortions since 2000, and "family planning advocates were lamenting a decline in adolescents' use of 'reproductive health services' such as family planning." He goes on to illustrate the conflicting opinions of Guttmacher: In 2008, they suggested that the sluggish economy reduced access to contraception and led to more abortions, but between 2008 and 2011 contraception was used more consistently because of the sluggish economy. Doerflinger asks, "Are we to believe that a Bush recession produces abortions while an Obama recession produces contraception? This theory seems a bit desperate. Generally abortion rates are higher, not lower, among women in poverty."

The number of abortion clinics fell from 378 in 2008 to 329 in 2011. Doerflinger asks, "What led so many clinics to close? Guttmacher provides part of the answer. It laments the 'disruption of services' produced by a law in Louisiana that made it easier to close such clinics...and the 24-hr waiting period enacted in Missouri...it complains about 'burdensome' laws regulating abortion, many of which have been passed since 2011 and so can be expected to play a greater role in future abortion numbers. Guttmacher's spin doctors call these 'TRAP' laws (targeted regulation of abortion providers), even when they only bring abortion clinics into line with standards already governing other clinics doing ambulatory surgery. For years, the abortion industry has been dragging these laws into court, claiming they place an 'undue burden' on women's access to abortion and will make clinics close entirely. Taking into account that these claims may be exaggerated or overheated to win a legal victory, does Guttmacher now want to claim that its allies have been lying in court? If not, it seems pro-life laws really do have an impact on the abortion 'supply'."

Doerflinger notes that pro-life laws "are made possible by a culture and public attitude against abortion, which can also influence women's attitudes and behavior directly. Sentiment against abortion...has been growing nationwide (especially among young people)...The national debate in the late 1990s on the grisly partial-birth abortion technique, the revelations about criminally dangerous abortionists like Kermit Gosnell, and the greater visibility of the unborn child due to advances like 4-D ultrasound have no doubt all played a role." Fewer doctors are willing to perform abortions. "Maybe more Americans are learning what abortion is: a violent act against life, a grief for women, a corruption of medicine, and an embarrassment to civilized society. Education to further advance that understanding should be accompanied by positive steps to help women at risk of abortion, and to help health-care professionals and policymakers address these women's real needs. In short, pro-life Americans should rejoice at the good news, and redouble their efforts to help pregnant women and their unborn children. Notwithstanding the spin doctors of the abortion industry, we are seeing some light at the end of that long dark tunnel."
