

Statements/Responses to the Supreme Court’s June Medical Services LLC v. Russo decision declaring the Louisiana law requiring abortionists to have admitting privileges in a nearby hospital unconstitutional, as it places an undue burden on women seeking abortions.

“Abortion violently ends the life of a child, and often severely harms women. Abortion becomes even more destructive when basic health and safety standards are ignored, and profit margins are prioritized over women’s lives. As Catholics, we condemn abortion as a grave injustice that denies the fundamental human right to life. Yet even as we seek to end the brutality of legalized abortion, we still believe that the women who seek it should not be further harmed and abused by a callous, profit-driven industry.

“The Court’s failure to recognize the legitimacy of laws prioritizing women’s health and safety over abortion business interests continues a cruel precedent. As we grieve this decision and the pregnant women who will be harmed by it, we continue to pray and fight for justice for mothers and children.

“We will not rest until the day when the Supreme Court corrects the grave injustice of *Roe* and *Casey* and recognizes the Constitutional right to life for unborn human beings. And we continue to ask all people of faith to pray for women seeking abortion, often under enormous pressure, that they will find alternatives that truly value them and the lives of their children” (Archbishop Joseph F. Naumann, USCCB Pro-Life Chairman)

"For too long, abortionists have flouted the law and derided health standards for women seeking abortion. As a Louisiana legislator, I authored one of the first abortion clinic regulations in the country to stop abortion clinics from operating in filthy, disgusting, unregulated conditions. Unfortunately, in Louisiana and elsewhere these facilities have shown minimal concern for the well-being of women as many continued performing abortions in marginal conditions that put lives at risk as they falsify records to cover up their malpractice. With this decision, the Supreme Court has prevented Louisiana from enforcing the law to stop abortionists who regularly deride and violate health standards for women seeking abortion...the case was not about the Supreme Court's self-created 'right' to an abortion in *Roe*. This case was about whether the state has the right to ensure that abortionists who take women's money also provide for their safety.” (Tony Perkins, President, Family Research Council)

"With its decision today, the Court has destroyed the right of states to provide oversight and regulation of abortion clinics, treating them like every other outpatient surgery center. The Court failed to clarify that abortionists cannot truly represent the interests of women when contesting health and safety requirements designed to protect those very same women.

"Not only do we disagree with the Court's ruling that hospital admitting privileges create an 'undue burden' for women, but we also strongly disagree with the decision that abortionists should be able to automatically represent women in court. There is a clear conflict of interest with abortionists representing women as they prioritize profit over women's health." (Katherine Beck Johnson, attorney and Research Fellow for Legal and Policy Studies at Family Research Council)

“Pro-abortion groups have made it clear that they care more about their bottom line than the women they claim to serve. If the abortion industry were really concerned about women, they would *want* an admitting privileges requirement in order to reassure women that they are getting good care.” (Carol Tobias, President, National Right to Life)

“The purpose of this law was to increase the safety for women having abortions. Louisiana passed the law after determining that several current abortion practices within their state were sub-standard: specifically, that unqualified or under-trained practitioners were performing abortions (including an ophthalmologist and radiologist) and clinics were not meeting basic licensing safety standards...The patients were left alone to find a medical facility and medical provider to care for them in the event of any complications...In sum, abortion clinics were being held to a different and lower standard than other outpatient surgical centers in Louisiana.” (Kevin Weary, MD)

“It should be noted that the Supreme Court is not Constitutionally bound to adhere to previous court decisions. If that were the case, it would never have been able to overturn its 1896 ruling in favor of segregation. Fallible human justices will make erroneous decisions, and should take the opportunity to correct them when they can. Justice Thomas is correct in his dissenting opinion when he says, “The Court’s current formulation of the stare decisis standard does not comport with our judicial duty under Article III, which requires us to faithfully interpret the Constitution.” State Sen. Katrina Jackson (D), who authored the bipartisan Louisiana law requiring that abortion clinics be held to the same standards as surgical centers, said she was “disappointed” that the court threw out a law that she said would “protect women injured in abortion facilities.” (*Weekly News Summary*, July 1, 2020, My Faith Votes Intersect Report)



FEDERAL LEGISLATION

HR.6800 (*HEROS* act), passed the House and had a Senate hearing July 23. It adds funds to the Paycheck Protection program but could also fund abortions. [See LN, Jul/Aug p3]. US Treasury & the Small Business Admin. told lawmakers that NARAL, 43 PP affiliates and

many private abortuaries got PPP funds they should not have. PP alone got \$66M - \$135M. **S.3709**, to correct this, has been in committee since May.

S.3388, the *Women's Right to Know* Act, mandates all states give women informed consent info before an abortion. Sitting in committee since March.

On June 18, GOP Senators Hawley, Lankford, & Lee blocked an attempted "unanimous consent" vote on the Equality Act, **S.788**, which threatens Conscience Rights.

HR.1055, the *Global Health, Empowerment and Rights Act*, is in committee. (Reps. Meeks, Rice cosponsor). It would fund the UNFPA, and ban the 'Mexico City Policy', thus allowing foreign aid to overseas abortion organizations.

House GOP members have attempted 81 times to force a vote on **HR. 962**, the *Born-Alive Abortion Survivors Protection* Act. In July, GOP Reps on the House Appropriations Comm. tried to add an amendment similar to **HR.962**, to **HR.7608** the *Dept of State, Foreign Operations, etc., Appropriations Act*. It failed, 24 to 28, but put 26 Dems on record, voting to not stop infanticide. There are no LI Representatives on this committee. The House then passed **HR.7608**, 224-189. [Reps. Meeks, Rice, Suozzi - yea ||| Reps. King, Zeldin - nay] It has many "poison pills" to undermine current pro-life U.S. overseas policies. It is unlikely to pass the Senate in its current form.

SCOTUS ruled 7-2 that the *Little Sisters* and other religious and moral objectors to the HHS abortifacient/ sterilization/ contraceptive mandate, are exempted by HHS rules issued during this Administration and the Religious Freedom Restoration Act. Justice Kagan, although concurring, thought the moral & religious exemptions were too broad. Dems have introduced **HR.7517** to override the exemptions.

SCOTUS struck down *June Medical Services LLC v. Russo*, Louisiana's law mandating abortionists have hospital admitting privileges. Pro-abortionists said it was the same as the Texas law (*Hellerstedt*) SCOTUS struck down in 2016. But the bill's author, State Sen. K. Jackson, noted her state has long required privileges, and they're easier to retain. Chief Justice Roberts was widely panned for casting the fifth vote against *June*. He explained his vote as *stare decisis* - respecting prior Court decisions, especially long-standing ones. Dissenting Justice Thomas wrote that *Roe* was badly decided, and Robert's analysis elevates prior bad Court rulings over the Constitution and legislation. Justice Alito noted 'standing' problems with *June* - to paraphrase: 'State rules for abortionists, to protect the health of their clients, were fought in Court by those abortionists, saying they are speaking for clients' health'. Some pundits say don't ask for 'conservative' Justices, but *originalists* or *textualists*. Others say forget

Courts, and push for Personhood laws, such as **HR.305** or **HR.616**, to make the preborn legal persons.

In *US Agency for International Development v. Open Society Int. Inc.*, the Court ruled overseas groups cannot claim 1st Amendment Rights and the restriction stands. This is good news for "Mexico City" ban on foreign aid funding overseas abortions.

On June 10, a Federal Court upheld the Administration's *Protect Life Rule*, meaning *Title X* recipients who do abortions must use separate facilities and staff. PP never agreed, and lost funds.

Three recent Executive Orders: (1) To work with faith-based & community orgs. to reduce the need for foster care and push adoption of children in foster care. (2) Re: ObamaCare: refusing to do abortions does not equal sex discrimination. (3) To push US religious freedom policy via the State Dept, USAID and UN. (The UN Human Rights council recently made an abortionist, Dr. Mofokeng, "Special Rapporteur on the right to health".)



NEW YORK STATE LEGISLATION

S.6311-Hoylman/A.8212-Glick is a bill aimed at Pregnancy Help Centers ("limited service pregnancy centers"): The Health Commissioner will name a group to investigate PHCs. The group must include an abortionist and an 'abortion rights' activist. PHCs must fill out loads of paperwork. PHCs must send NYS info on their clients. Such info could violate medical privacy laws.

The bill passed the Assembly 99-43. **Voted YES** - Thiele, Englebright, Ramos, Stern, Jean-Pierre, Lavine, D'Urso, Darling, Griffin, Solages. **Voted NO** - Palumbo, DeStefano, Smith, Garbarino, Fitzpatrick, LiPetri, McDonough, Montesano, Mikulin, Ra, Miller, ML (Note: Assembly Dist. 12 is vacant)

For reasons that aren't clear, the State Senate adjourned without voting on the Bill, but they could reconvene at any time to vote.

A.7816 Manktelow /S.5332 Helming is a NYS 'Born Alive' Law. Latest action, July 13: it was 'held for consideration' in the Assembly Health Committee.

On July 6, the Albany Diocese lost its appeal (*Albany v Vullo*) against a 2017 NY regulation that all health insurers cover "medically necessary" abortions.

PP of Greater NY fired Chief Exec. Laura McQuade in June. High staff turnover, a \$6M loss, and a staff group alleging she 'brutally shamed' and 'gaslit' her staff, acted "Trumpian", and possibly racist led to her firing. The group stated, "PP was founded by a racist, white woman." On the same day, PP announced it would fight 'systemic racism' by promoting birth control for Black Americans. PP later announced it was taking Margaret Sanger's name off its NYC HQ and asking NYC to rename the Square. (Note: The Official Black Lives Matter website says the organization supports "reproductive justice", aka abortion.)

Racism and Eugenics



Brian Clowes, PhD, Director of Research for Human Life International posted an article on hli.org (7/21/20) entitled “*The Racism of Eugenics*.” He begins by stating, “We have seen that eugenicists in general focus entirely on a person’s physical characteristics when gauging their perceived usefulness to society. This purely utilitarian thinking has culminated in the attempted extermination of entire classes of people — the handicapped, the elderly, other ethnicities, and Jews. The only difference between eugenics practice a century ago and in our current day is that now, those who are deemed non-productive or “unwanted” are killed individually instead of *en masse* — usually by the people who should be protecting and caring for them. From its beginning, the leadership of the eugenics movement has been drawn exclusively from influential white elitists. And those targeted by eugenics measures have invariably been minorities, the poor and the powerless.”

Julian Huxley, an evolutionary biologist and eugenicist, wrote in his 1946 report *UNESCO: Its Purpose and Its Philosophy*, “At the moment, it is probable that the indirect effect of civilization is dysgenic instead of eugenic; and in any case it seems likely that the dead weight of genetic stupidity, physical weakness, mental instability, and disease-proneness, which already exist in the human species, will prove too great a burden for real progress to be achieved.”

Clowes notes that Huxley’s report was issued the year after WWII ended. “...eugenicists learned nothing from the Nazi horror. And now that we are well into the 21st Century, we have witnessed *absolutely nothing* has changed. The eugenic evil has been camouflaged and perfumed – but it is still as great a danger as it ever was.”

Clowes states that eugenicist Lothrop Stoddard’s 1922 book, *The Rising of Color against White World-Supremacy* “demonstrated beyond a shadow of reasonable doubt the intimate connection between eugenics and goal-oriented racism which is also the motivating force behind the worldwide population suppression movement.” Stoddard stated, “We or the next generation will take in hand the problem of race-depreciation; and segregation of defectives and abolition of handicaps penalizing the betters will put an end to our present racial decline.”

Clowes reflects, “Stoddard’s prediction has unfortunately been fulfilled. The Culture of Death in *our* time that has eagerly taken up the task of “abolishing handicaps” with the devastatingly effective weapons of amniocentesis, abortion and infanticide. And they are targeting other races on a worldwide scale; two-thirds of all population control dollars expended by the West over the past two decades have been directed towards suppressing the populations of African nations.”

Stoddard sat on the board of founder Margaret Sanger’s American Birth Control League, now known as Planned Parenthood. Planned Parenthood is the largest provider of abortion services in the United

States. Sanger was an ardent eugenicist who believed in “racial hygiene”. She wrote in *The Eugenic Value of Birth Control Propaganda* (1921), “Today eugenics is suggested by the most diverse minds as the most adequate and thorough avenue in the solution of racial, political and social problems.”

Michael Cook, editor at MercatorNet.com, wrote on July 27 that Sanger “favored sterilization of the genetically unfit, keeping the diseased and “feebleminded” from immigrating, and segregating so-called illiterates, paupers, unemployables, criminals, prostitutes, and dope fiends. She endorsed the Supreme Court’s notorious 1927 *Buck v. Bell* decision.

In response to the Black Lives Matter movement, Planned Parenthood of Greater New York announced that it will remove her name from its flagship New York City clinic due to her “harmful connections to the eugenics movement... The removal of [her] name from our building is both a necessary and overdue step to reckon with our legacy and acknowledge Planned Parenthood’s contributions to historical reproductive harm within communities of color.”

The group Black Genocide states that half of African American women who become pregnant abort their babies and a black baby is five times more likely to be killed in the womb than a white baby. Rev. Clenard H. Childress Jr., head of Black Genocide said, “The most dangerous place for an African American to be is in the womb of their African American mother.” Blacks comprise 13% of the US population, but account for 37% of all abortions.

In the past, Planned Parenthood defended Sanger’s positions, claiming her quotes were taken out of context. In 1939 she wrote a letter to Dr. Clarence J. Gamble, a strong supporter of the birth control movement, and stated, “We do not want word to get out that we want to exterminate the Negro population.” Cook wrote, “Sanger wanted to counter the vehement conviction of black nationalist Marcus Garvey and others that birth control was being used to “eradicate the black race.” She proposed enlisting black doctors and ministers of religion in Planned Parenthood’s public relation campaign to reduce the number of black babies.” Cook concluded, “The real problem for Planned Parenthood is not Margaret Sanger’s odious views on eugenics. It’s abortion and it needs to confront that squarely. “Planned Parenthood’s contributions to historical reproductive harm within communities of color” are its core business.”

Clowes commented, “The corrupt and racist theory of eugenics, which seeks to create a “race of thoroughbreds” through birth control, abortion, and sterilization (without consent, if necessary) certainly did not die in a bunker with Adolf Hitler in 1945. Many of the world’s most distinguished and influential scholars and social engineers still advocate the widespread use of eugenics to rid society of its ever-present ‘undesirable elements’... In short, eugenics and racism are very much alive today, working closely together against minority races and the lower classes. The idea of negative eugenics, or preventing ‘lesser’ people from reproducing, is sadly still at play in modern society, intimately connected with true racism. We are witnessing the growth of a branch of *positive* eugenics that might be called ‘self-directed evolution.’ This mania has lost sight of who we truly are as human beings, and of God’s plan for our lives.”


