DOES YOUR SCHOOL HAVE TIPS?

Teen Information and Peer Services (TIPS) is a Planned Parenthood program created to train teenagers "to talk to other teens about health and human sexuality." Teens act as peer educators, "client advocates", "resource guides" and help "plan" their annual Teen Health Conference. According to PP, TIPS educators learn skills for making responsible choices and share information with other teens at school. In short, TIPS serves as a conduit between school-age teens and PP's "confidential" services – contraception, abortion and treatment of STD's without parental notification or consent.

Why would any school allow teens to counsel teens on these sensitive subjects without parents knowing about it? Some schools are unaware of the existence of TIPS, others allow it to exist even though they know that PP has a vested financial interest in promoting promiscuous premarital sex, the sale of contraceptive devices and abortion.

PP talks about <u>choice</u> but doesn't give parents a choice with their constant opposition to parental notification or consent. It's up to <u>you</u> to ask your School board if they've allowed a PP TIPS program to exist in your school.

THE WOMEN AND CHILDREN RESOURCES ACT HR 2901

"If today's women need choices, we must offer them real choices", said Rep. Joseph Pitts, (R-PA) In introducing H.R. 2901.

Please support the Women and Children Resources Act HR 2901. The bill would establish \$85 million for pre-natal and post-partum health care to women and children in crisis situations as an alternative to abortion. SUPREME COURT TO REVIEW BAN ON PARTIAL-BIRTH ABORTION (PBA)

24 hours after the 7th Circuit Court of Appeals in Chicago ruled to sustain a ban on PBA, the same court arbitrarily reversed its decision. Illinois and Wisconsin will now have to wait for the U.S. Supreme Court to decide on the constitutionality of their state bans before they can be enforced. In April the Supreme Court will review Nebraska's ban on PBA and will make a decision in June 2000. Their decision will affect all PBA bans passed by states.

NEW YORK STATE

On the back page of our March 2000 Pro Life News there was an article describing unsafe conditions at "Choices" abortion clinic.

ACTION: Letterwriting (sample letter follows:)

Dear Governor/Senator/Assembly Member:
As you know, Choices Women's Medical

Center of Long Island, one of the largest in the nation, was closed for "problems that pose a significant risk to the welfare and safety of patients." The director of the clinic was Dr. Allan Zarkin who was fired from Beth Israel Hospital for carving his initials into the stomach of a patient. Does not the State Health Department's Statement of Deficiencies (11 pages) show a need for much stricter oversight and more severe penalties in the regulation all abortion clinics?

Violations at Choices include: an "assembly-line pace" leaving insufficient time to monitor patients before and after surgery, inadequate staffing of nurses and assistants, no functioning equipment to monitor patients under general anesthesia. Choices was fined \$2000 for each deficiency. A clinic that performs an abortion every five minutes could pay a \$2000 fine out of fees generated by less than one hour of services.

Please use your position to urge stricter oversight and realistic penalties. The true answer to the abortion industry's exploitation of women in crisis lies in the respect for human life, and affording women alternatives that insure their health and safety and that of their unborn children. While we in the pro-life movement work toward such goals, in the meantime we demand vigilant monitoring of this industry of death. Please reply. Thank you.

HEALTH & SCIENCE REPORT



EUGENICS - GENETICS

Do we need the pro-life International Foundation for Genetic Research, popularly known as the Michael Fund? Long before the Roe v Wade and Doe v Bolton decisions of the Supreme Court in 1973, an evil eugenics program was spreading its tentacles wide to usurp the rights of every child to be born and accepted, especially if the child was physically or mentally challenged. Foundations that were established to offer the intervention needed for these very children and their parents were already funding eugenic symposiums and research which would terminate the lives of affected preborn babies by abortion rather than searching for a cure or the therapy needed for these children to reach their potential.

In 1883, Frank Galton, an English scientist and relative of Charles Darwin, coined the word "eugenics" from the Greek root meaning good-in-birth. This word then would be used to denote the "science" of improving the quality and increasing the quantity of "superior" human stock, while simultaneously weeding out and eliminating "inferior" or "unfit" human stock. Sounds a lot like the Margaret Sanger/Planned Parenthood philosophy! One of the nation's leading eugenics organizations, The Cold Spring Harbor Experiment Station for the Study of Evolution was based right here on Long Island. It was heavily financed by Andrew Carnegie.

The National Foundation for Infantile Paralysis, later named the National Foundation/March of Dimes (MOD), had and has a commitment to eugenics. Their key officials accepted the premise that ". . . there are certain people who never should be born and that it is a positive act for families and society to insure that such persons are not born." MOD has funded symposia headlined by pro-abortion speakers, sat eugenicists on their National Advisory Committees, and funded and promoted mid-trimester, non-therapeutic prenatal diagnostic research. This research has been dominated by nationally known eugenic abortionists famed for their late term abortion technical skills, especially prostaglandininduced abortions, which provide fresh fetal tissue and organs. MOD has also supported clinical testing including ammiocentesis, fetoscopy, chorionic villus sampling and maternal blood sampling. Many of these prenatal diagnostic procedures could maim, cause medical complications or death to the child. In addition MOD furnished seed monies to expand eugenic services at university-based medical centers throughout the US.

As reported in the Catholic Family News in December 1999: "A number of MOD grantees have used aborted babies as a source of spare parts or fetal blood. During the 1970's and early 1980's, it was MOD's private foundation monies that permitted ... researchers ... to bypass the government ban prohibiting the use of federal funds for such non-therapeutic, lethal experimentation on live human fetuses. A virtual international 'medical underground' was created to supply fresh human fetal tissues, blood or organs to 'needy' researchers both in the US and abroad." Just one example of MOD financed research: Peter A.J. Adam

used the severed heads of live aborted babies between three to five months gestation (12-20 weeks) in his fetal brain fuel metabolism experiments conducted at the University of Helsinki, Finland. There are many more experiments, just a ghastly, which MOD has funded. Nazi researchers were hanged for similar actions. Thinking about the above experiments, take into consideration the explanation of fetal pain by Dr. V. Collins, Diplomate and Fellow, American Board of Anesthesiologists: "As early as 8 - 10 weeks gestation, and definitely by 13 1/2 weeks, the human fetus experiences organic pain."

Did we need a pro-life foundation? Semantics came into play to change the opinions formed by those who had heard about the horrors of the experimentation carried out by eugenicists. The term eugenics was replaced with human genetics or medical genetics. The newly titled "geneticists" unfortunately did not change their experimental practices!

Please do not misunderstand. There are many very moral geneticists and there is a legitimate place for this science. What we do not need are foundations that support experimentation that is not life-giving and research doctors that are not pro-life. We revere the memory of the late Dr. Jerome Lejeune, world famous pro-life geneticist, and celebrate the work of his colleague, Dr. Marie Peeters Ney and Dr. Paddy Jim Baggot. Of course, that leads us right to The Michael Fund founded in 1978 to support pro-life genetic research, offer support services and adoption networking for babies to be born specially challenged. Dr. Lejeune was Medical Director of The Michael Fund until his death in 1994. Dr. Peeters Ney is the present Medical Director, and Dr. Baggot will extend the research started by Dr. Lejeune. Dr. Baggot's research project is Biochemical Analysis of Folate-Dependent Metabolites in Amniotic Fluid. His research does not invade the mother's or unborn baby's bodies, as he evaluates previously stored amniotic fluid from Down Syndrome and non-Down Syndrome pregnancies. "... findings suggest that mental retardation resulting from disordered brain development in the preborn patient with Down Syndrome (Trisomy 21) begins after 22 weeks gestation (Volpe, 1995; Wisniewski et al. 1984). These findings open up the possibility of treatment of metabolic defects early in the pregnancy aimed at decreasing neurological damage to the affected pre-born child." We will be publishing shortly an update on Dr. Baggot's research.

WORDS MEAN EVERYTHING

Those who support abortion have quite successfully engaged in semantic gymnastics. So before you speak consider the following: ■ We became "right-to-life." This is the best title. Use it always. Can you imagine a nation accepting a "mother's right" to abortion? ■ The U.S. Supreme Court Decision of 1973 should always be described as "the tragic..., the savage...," and like terms. ■ Always say "salt poisoning abortion," never "saline abortion". ■ "Interruption of pregnancy" is an absurd and inaccurate use of words. 

QUESTIONS & ANSWERS

Questions: How did the Supreme Court justify its action in the Roe vs Wade abortion ruling?

<u>Answer</u>: It seems obvious that the court approached the issue with a clear conviction that "A woman must have this right" and tried to justify this right. They admitted their decision was not in the constitution, but claimed that it was implied. (emphasis added)

Justice Douglas, in Griswold v. Conn. had found (created) a new right to privacy. He found it in the emanations (vapors) from the Penumbra (shadow) of the 14th Amendment. Justice Blackmun planted the abortion right firmly upon this foundation. (emphasis added)
