Take Back Your Rights As Parents

The following presentation was given at the Smithtown School Board Meeting on March 14.

"I am here to voice my strong opposition to any involvement of the Smithtown School District with the controversial organization, Planned Parenthood. As parents, we were never notified that Planned Parenthood was invited into the school last Fall to present their agenda to our children.

The principal was not aware that no notification was sent home to the parents. My husband and I have a letter from an attorney on file with the school to avoid this very thing happening. This is why I urge the Board to consider having an opt-in program for all health or sex education classes. This way the school would not be leaving themselves open to lawsuits and the parents would be able to take back their role as their children's primary educators of health and sex education.

Working as a facilitator with unwed, teenage mothers involved in crisis pregnancies, I see first-hand the results of Planned Parenthood and their programs. I was told by one of these young woman, who just graduated from Smithtown High School, that it is common among many of her friends in the school to have up to four and five abortions – they are using abortions as birth control. The psychological, emotional, and physical damages to these exploited, young women is immense, along with the long-term effects this could have on the fathers of the babies. As these young women pointed out to me, you never hear from the mother or father who was lead to have an abortion by Planned Parenthood. Since the arrival of Planned Parenthood, there have been over 6,000 abortions in the Smithtown area – Planned Parenthood's message is NOT working.

I suggest removing Planned Parenthood from our school district, just as other Long Island School Districts have done. Smithtown School District should take a leadership role in addressing these problems head on, and not be a follower of Planned Parenthood: an organization with a very poor track record in solving the problems they claim they want to correct.

Smithtown School District needs to provide <u>abstinence-based programs - the only real safe sex alternative</u>; which set high goals, enhance a student's sense of self-worth, and foster an environment of respect for themselves and each other. Planned Parenthood aims at the lowest common denominator (which is always achievable) but with horrendous results. We must do better than this! Please do all you can to implement an opt-in program, provide ongoing abstinence programs, and seriously consider removing Planned Parenthood from our school district. Thank you for your consideration."

My husband and I implore all parents to take an active role and see what Planned Parenthood is teaching our children, without our consent or knowledge. Take back your rights as parents!

BAN ON PARTIAL BIRTH ABORTIONS

(PBA)--On 4/5/00 the ban on PBA passed the House by a vote of 287-141, a wide enough margin to override a presidential veto. This bill now moves to the Senate where previously Sen. Moynihan voted to ban PBA but Sen. Schumer voted for PBA.

How our Nassau/Suffolk Congress Members voted on Partial Birth Abortion: Reps. Forbes, Lazio and King voted to ban PBA. Reps. McCarthy and Ackerman voted to continue the Partial-Birth Abortion procedure.

HEALTH & SCIENCE REPORT



TRUTH AND INJUSTICE

An upcoming US Supreme Court decision and 3 calls in one week from medical personnel about facts on partial birth abortion (PBA), persuaded us to do another article on this horrific abortion procedure. Whatever it's called, a D & X (dilation and extraction) abortion is infanticide. Proabortion advocates perpetually attempt to draw attention away from the truth of this gruesome procedure by belittling our use of the terminology "partial birth" as being medically incorrect or nonexistent. They are attempting to get us to use a title that does not describe as vividly what is really taking place.

We repeat here the barbaric procedure, which we feel is not only an inhuman injustice to the baby, but is totally unnecessary and dangerous to the mother:

"The surgeon introduces a large grasping forceps... through the cervical and vaginal canals into the corpus of the uterus. When the instrument appears on the sonogram screen, the surgeon is able to open and close its jaw to firmly and reliably grasp a lower extremity. The surgeon then applies firm traction to the instrument causing a version of the fetus (if necessary) and pulls the extremity into the vagina. . With a lower extremity in the vagina, the surgeon uses his fingers to deliver the opposite lower extremity, then the torso, the shoulders and the upper extremities. The skull lodges at the internal cervical os. . The fetus is oriented dorsum or spine up. At this point, the right-handed surgeon slides the fingers of the left hand along the back of the fetus and 'hooks' the shoulders of the fetus with the index and ring fingers (palm down). ...While maintaining this tension, lifting the cervix and applying traction to the shoulders with the fingers of the left hand, the surgeon takes a pair of blunt curved Metzenbaum scissors in the right hand. He carefully advances the tip, curved down, along the spine and under his middle finger until he feels it contact the base of the skull under the tip of his middle finger. . the surgeon then forces the scissors into the base of the skull. . Having safely entered the skull, he spreads the scissors to enlarge the opening. The surgeon removes the scissors and introduces a suction catheter into this hole and evacuates the skull contents. With the catheter still in place, he applies traction to the fetus, removing it completely from the patient."

Remember, the baby is alive and often moving during the brain suctioning, and numerous studies have shown that a fetus does feel pain, perhaps even more than a young child.

Some of the risk factors for the mother are: The turning of the fetus to a breech position causing amniotic fluid embolism or placental abruption, according to Dr. Warren Hern, author of the textbook, "Abortion Practice." The booklet For Mother and Child by Dr. Mary A. Nicholas includes the testimony of Dr. Pamela Smith at a Senate hearing that forcefully dilating and opening the cervix could cause an "incompetent cervix," which might prevent a woman from carrying a subsequent

baby to term. Another risk is a perforated uterus. If the abortionist perforates a major artery, a woman could die in 5 minutes.

The pro-abortion website of The Alan Guttmacher Institute (AGI) (http://www.agi-usa.org) contains misinformation and avoids the facts: It reports on the 12/96 meeting of the American Medical Association where one of their considerations was supporting the criminalization of D&X abortions. They report that the Reference Committee recommended that the AMA "reaffirm its pro-choice policy" and that "governmental interference into the practice of medicine is inappropriate and ultimately harmful to the patient." They never mention that at the 5/97 meeting, the AMA endorsed the federal ban on PBA, saying the procedure should be criminalized because it is "not good medicine." Drs. M. LeRoy Sprang and Mark Neerhof say in the 8/26/98 Journal of the AMA "PBA is unsafe for pregnant women, painful for children, and unethical because of fetal viability." The AGI report projects a total of 650 D&X abortions in 1996 and 201 in the first half of 1997. However, Ron Fitzsimmons, Exec. Dir. of the National Coalition of Abortion Providers estimates that 3,000-5,000 are performed annually. In 1997, The Record in Bergen, NJ, reported 1,500 PBA's at one NJ clinic alone!

According to "Reproductive rights activists" in the AGI report, D&X abortions are necessary for "postviability pregnancies gone terribly wrong—when the fetus is severely incapacitated or the women's health or life are at grave risk." However the NYS Catholic Conference reports that the physician who developed the PBA method, Dr. Martin Haskell, has acknowledged that the large majority of these procedures, 80% by his estimation, are "purely elective"—performed on healthy mothers carrying healthy babies.

At the Senate hearing, Dr. Pamela Smith testified that "there are absolutely no obstetrical situations encountered in this country which require a partially delivered human fetus to be destroyed to preserve the life or health of the mother."

Nebraska's ban of PBA is before the US Supreme Court this term. A decision should be handed down in June. The House of Representatives recently passed another PBA ban bill.

"The baby parts market makes PBA abortion more popular than ever. The PBA technique delivers an almost entirely intact, fresh 'specimen' to the baby parts traffickers—which means top dollar for the abortionists. Likewise, other abortion techniques require the abortionist to bear the expense of disposing of some portions of the 'cadaver.' With PBA, there are no leftovers—and, in fact, the 'traffickers' actually pay the abortionist for the privilege of carting off the corpse." (Coral Ridge Ministries Media, Inc. 2000)

Write, call, and pray that the PBA ban will not be vetoed.





Pro-Abortion Assembly Resolution Withdrawn!

On Monday, April 10, 2000, Assembly Majority members Richard Gottfried (D-NYC), Sheldon Silver (D-NYC) and others introduced Assembly Resolution Number 2102 to "commemorate the 30th anniversary of the New York State Legislature's historic April 11, 1970 vote establishing legal abortion" in the state. The resolution recognized a group called "Champions of Choice," scheduled to have a luncheon on April 11, 2000 to "celebrate the anniversary of legalized abortion."

Seven Assembly members in a row,
Democrats and Republicans, pro-life and prochoice, stood to vehemently object to the
resolution. They called it "disrespectful,"
"outrageous," "insulting," and "demeaning to those
who oppose abortion on moral grounds." Several
noted that they could not recall anything like it
before in the history of the Assembly.

Even members with pro-abortion voting records such as Nancy Calhoun (R-New Windsor) and George Winner (R-Elmira) stated that the issue divides the people of the state, and the legalization of abortion is not something to be celebrated. Assembly member Joel Miller (R-Poughkeepsie), while noting his pro-choice feelings, stated, "To dance on the graves of the unborn is a terrible thing to do."

The seven members who spoke on the floor of the Assembly to object to the resolution were:







UNDERPOPULATION VS. ECONOMIC VITALITY

February 17, 2000: Federal Reserve Chairman Alan Greenspan, in recent testimony before Congress, has said he wants to increase the annual immigration quota by 130,000 to meet the needs of a tightening labor market. Help wanted signs are blossoming in cities and towns throughout the country and employment levels are at historic highs. At the same time, President Clinton is paradoxically preparing to extract from the U.S. taxpayer record sums almed at further reducing the number of babies born at home and abroad. America's present-day labor shortage was in part created by policy decisions made three decades ago. By 1970 the national media were claiming that the most pressing issue of the day was overpopulation. John D. Rockefeller pushed the Nixon administration to act to curb the US population growth rate claiming above-replacement birth rates threatened "the vitality of business". In other words, he got things exactly backwards. By 1977, America's birthrate had dropped below replacement levels and it is interesting to note that the 1977 shortfall in births was approximately 130,000, exactly the number Greenspan noted we now need annually! In view of our current labor shortage, the Clinton administration's effort to increase funding for domestic population control programs by \$35 million seems particularly shortsighted. We are already experiencing a birth dearth of historic proportions that is threatening to cripple the economy. 
