



### FEDERAL LEGISLATION

#### **NOVEMBER ELECTIONS**

The outcome of this November's election will determine the fate of the innocent unborn. Presidential candidate Barack Obama as an

Illinois State Senator and as U.S. Senator has long supported abortion on demand. On the other hand, Senator John McCain has an almost perfect pro-life voting record while serving several terms in the Senate. It is vital that we choose candidates who will stop the slaughter of our precious pre-born.

### **PRO-LIFE LEGISLATION**

The success of two pro-life bills, "The Sanctity of Human Life Act (HR 4157) and "The Life at Conception Act" HR 618 presently in the House sub-committee and Judiciary will be instrumental in bringing down the Supreme Court decisions of 1973. The high court's Roe v. Wade and Doe v. Bolton decisions forced abortion on demand down our nation's throat.

"The Life at Conception Act" declares unborn children "persons" as defined by the 14<sup>th</sup> Amendment to the Constitution, entitled to legal protection. This is the one thing the Supreme Court admitted in Roe v. Wade that would cause the case to collapse. The 14<sup>th</sup> Amendment couldn't be clearer, it says: "Congress shall have the power to enforce, by appropriate legislation, the provisions of this article."

The "Sanctity of Human Life Act" now has 61 co-sponsors. It would establish legal personhood for all human beings from the moment of fertilization.

Continue to urge your Senator and Congressional Member to support both bills.
