#### League of Women Voters www.lwv.org

The League of Women Voters' position on Health Care Reform is: "Every U.S. resident should have access to affordable, quality health care, including birth control and the privacy to make reproductive choices."

An LWV blog post (https://www.lwv.org/blog/ honoring-roe-v-wades-40th-anniversary) titled "Honoring Roe v. Wade's 40th Anniversary (1/22/13) said: "Today, the League marks the 40<sup>th</sup> anniversary of *Roe v. Wade*, the landmark Supreme Court decision that legalized abortion in the United States. For decades, the League has championed Roe v. Wade, both for upholding the right of individuals to make their own reproductive choices and the constitutional right to privacy."

#### FEDERAL LEGISLATION

As of 3/11/19, there have been 14 failed requests for a House vote on **HR.962/S.311**, the Born-Alive Abortion Survivors Protection Act, and two failed tries in the Senate. (The 53-44 vote on 2/25/19 in the Senate was seven votes shy of the 60 votes needed to proceed). Both NY Sena-

tors (Schumer & Gillibrand) voted *No*. Rep. Zeldin is the only L.I. cosponsor of the House bill. This bill improves the existing 2002 *Born-Alive* Act by requiring health workers to treat abortion survivors like any 'preemie' born at the same age. It creates penalties for the intentional killing of those survivors and gives the birth mother a private right to sue the killer.

The **HR.21** spending bill still sits in the Senate awaiting action. There are anti-life parts of the bill, which the Senate may remove, if it acts on the bill. The bill includes additional funding for the UN Population Fund which worked with China on its One-Child Policy. HR.21 would also hobble the pro-life 'Mexico City Policy' which blocks foreign aid to non-government organizations performing abortions.

The *Protect Life Rule* will take effect April 23<sup>rd</sup>. Any organization receiving *Title X* 'family planning' funds will have 120 days to financially separate family planning and abortion, and one year to put family planning and abortion services and staff in separate buildings. Planned Parenthood is not expected to comply, which would result in the loss of up to \$60M. Planned Parenthood has filed suit. The US Supreme Court permitted similar rules in 1991. However, the Clinton administration ended those earlier rules.

A 2014 Louisiana law requiring abortionists to have hospital admitting privileges was set to take effect on February 8th. However, the US Supreme Court issued a stay in order to allow a study of whether the law would put an 'undue burden' on women. Alito, Gorsuch, Thomas, and Kavanaugh dissented. Pro-abortionists claim this law was the same as Whole Women's Health v Hellerstedt, struck down by the Supreme Court in 2016. Justice Roberts had voted to uphold that law in 2016, but this time voted to stay the Louisiana law. Some pro-lifers are concerned Roberts (and possibly Kavanaugh) view precedent as more important than their own conclusions about the Constitution. Kavanaugh voted against the stay, but wrote it was because the law gave the State's three abortionists ample time to apply for admitting privileges. Kavanaugh seemed to concede their 'undue burden' claims. Americans United for Life stated they're confident the Court will uphold the law in the end. However, First Liberty's Josh Hammer said it is "madness" for pro-lifers to continue putting all their political capital in the "nine robed oracles".

Other possible cases which may be taken up by the Supreme Court include *Box v. PP* and *Rooks v. Rooks. Box v. PP* involves an Indiana law banning abortion because the unborn child has Down Syndrome or other 'unwanted' traits. The Thomas More Society has asked the Supreme Court to take up the case of *Rooks v. Rooks*, to decide if a human embryo is a person or property. Mandy & Drake Rooks are divorcing. She wants their six frozen embryos preserved for possible future use, and he wants them 'destroyed'.

The HHS Department began reviewing all the research it sponsors using fetal tissue in September 2018. Yet the HHS recently extended for another 90 days a contract to create "humanized mice" for HIV research. Earick Ward, writes sarcastically (*americanthinker.com*, 2/13/19), that the women who supply Planned Parenthood with the fetuses whose parts they sell, should get a cut of the money. According to Ward, women are currently raising a cash crop for no pay.

# NEW YORK STATE LEGISLATION

When Jennifer Irigoyen (5 months preg-

nant) was stabbed to death in early February, her pre-born baby also died. The Queens DA wanted to charge Tony Hobson with murder and 2nd degree abortion. However, he quickly withdrew the abortion charge, since 'the Legislature had repealed that law'. Liz Krueger, NYS Senate sponsor of the RHA, responded that Hobson could be charged for 'an attack that ends a pregnancy', a firstdegree assault, carrying a longer jail term than 2nd degree abortion. We ask, is "ending a pregnancy" more serious than killing a pre-born baby? The result is the same for the pre-born child.

Third trimester abortions were performed in New York State **prior** to the passage of the RHA due to the broad definition of 'health' in *Doe v Bolton*, the companion decision to *Roe v Wade*. Numbers from the Guttmacher Institute indicate that each year, approximately 12,000 abortions, at 21 weeks gestation or more, occur in the U.S. The NYS Catholic Conference notes that 2,000 third trimester abortions occur in NY State each year. The RHA allows nurse practitioners, physician assistants, midwives, as well as other non -physicians to perform both chemical and surgical abortions.

New Yorkers for Constitutional Freedoms reports that Governor Cuomo publicly stated his support for paid surrogacy legislation and included it in his budget proposal. The Child-Parent Security Act – CPSA – Bill A.1071-A-Paulin was approved by the Assembly Judiciary Committee and is now in the Assembly Codes Committee. Currently NYS bans compensated surrogate parenting. Such agreements are inherently exploitative towards women and treat the unborn child as a commodity.

Compassion & Choices kicked off a campaign in January to promote doctor-prescribed suicide in NYS. Such legislation is a lethal threat to the elderly and disabled. A02694/ S03947 are currently in the Assembly and Senate Health Committees.

# HEALTH & SCIENCE "Late-Term Abortion"

The "Questions and Answers on Late-Term Abortion Fact Sheet" updated 2/1/19 by the Charlotte Lozier Institute (CLI) states, "'Late-term' abortion is an imprecise term. Authorities have disagreed on how the phrase should be defined, with some including any abortion performed after the 20<sup>th</sup> week of gestation and others limiting the term to the third trimester (approximately 27 weeks of gestation to delivery). Use of the term is also sometimes rooted in the concept of viability, or that stage of pregnancy where, on average, an unborn child can survive on its own outside the womb, albeit with artificial support...'viability' itself is a term whose application varies over time, occurring earlier in pregnancy as active treatment resources increase and medical equipment and skills improve. The U.S. Centers for Disease Control's abortion surveillance system uses greater than or equal to 21 weeks of gestation to delivery as its upper category, and the system does not distinguish abortions by week at that limit or above."

The Fact Sheet describes 'the dreaded complication' of "a child born alive despite the effort to kill him or her in utero...A number of victims of these procedures [saline or prostaglandin abortions] are alive today and testify to their experiences." Abortionists now attempt to "ensure fetal demise before delivery". The ban on partial birth abortion (delivering a child into the birth canal up to its shoulders and then killing it by crushing the skull) was banned by Congress in 2003 and upheld by the Supreme Court in 2007 (Gonzalez v Carhart). The current practice involves dilating the mother's cervix a day or two before the abortion, and injecting potassium chloride or digoxin into the heart or head of the unborn child to "ensure that he or she is dead upon delivery". On the day of the abortion, "uterine evacuation is then performed. For younger babies this can be primarily accomplished using suction to remove as much tissue and soft body parts as possible, followed by forceps removal of larger and harder body parts. For older and larger babies, dismemberment using forceps is used (grasping and pulling off limbs for removal). The brain is usually then removed by suction and the skull crushed for removal...Misoprostol may also be given to the mother to induce uterine contractions, especially to help expel all the body parts and placenta."

Fisher and Kimport reported in the journal *Perspectives on Sexual and Reproductive Health* in 2013 that "data suggests that most women seeking later terminations are not doing so for reasons of fetal anomaly or life endangerment." They found that reasons for abortion were basically the same for women who had abortions at 20 weeks and those who had abortions prior to 20 weeks. In 2018, Dr. Foster noted in a report for the Congressional Research Service "that abortions for fetal anomaly 'make up a small minority of later abortion' and that those for life endangerment are even harder to characterize."

The Fact Sheet states the "most recent data from the U.S. Centers for Disease Control and Prevention (CDC) on total abortions and late-term abortions suggests that approximately 1.3% of abortions are carried out at 21 weeks of gestation and above." However, this number is probably higher, since 12 reporting areas are not included in the CDC's calculations. "These reporting areas account for more than half of all abortions performed in the United States, and all but one permit abortion on demand after 20 weeks." The research arm of the abortion lobby, the Guttmacher Institute, surveys abortion facilities and estimates that over 926,000 abortions were performed in the US in 2014. That "translates into an estimated 12,040 late-term abortions in that year." California, Maryland, and New Hampshire do not collect any abortion data. Proabortion groups consider "government tracking of these data to be 'intrusive and unnecessary' – while acknowledging that information on women's reasons for abortion is critical to an understanding of abortion trends, public policy, and public opinion."

According to Dr. Donna Harrison, M.D., Executive Director of the American Association of Pro-Life Obstetricians and Gynecologists (AAPLOG), "Late-term abortions are much more dangerous for the mother than giving birth. Late-term abortions involve much higher risk of perforating the womb, massive bleeding, and damage to the womb. Late-term abortions are only safe for the abortionist, not for the mother, or her child. If a baby has died in the womb, the procedure is not an abortion. The purpose of abortion is to kill the unborn child to ensure that the child is born dead."

Dr. Christina Francis, Chair of the Board, AAPLOG states, "Women carrying children with life-limiting conditions need to be cared for in a way that not only maximizes maternal health, but also honors the life of their child. Delivering a child intact and then administering the appropriate medical care for that child – whether that be palliative care or active treatment – is the medically appropriate and ethical thing to do."

Dr. Byron Calhoun, perinatologist, noted, "There is never a reason to take the life of an unborn child since there is no maternal condition that requires the death of the fetus to save her life. The infant may need to be delivered prematurely and die as a result of that, but it is not necessary to take the infant's life. Further, if a fetus has an adverse prenatal diagnosis all patients should be offered perinatal hospice care since this is far better for maternal health than any elective abortion. Perinatal hospice allows the parents to be parents and provide all the love they can for their child."

The Fact Sheet concludes with information on a new subspecialty of OB/GYN – "Complex Family Planning Fellowship". The CLI Fact Sheet states, "the ONLY thing this new subspecialty will focus on that every other OB/GYN isn't already trained in is late-term abortion procedures...the [aim of this] grisly and unethical subspecialty...is to kill fetal human beings who are capable of surviving outside the womb." #### **GUIDELINES for PRO-LIFE PRESENCE at PRO-LIFE EVENTS and ABORTIONIST'S SITE**

All public pro-life witnessing MUST BE PEACEFUL. This is legal nonviolent direct action. Public pro-life outreach is a statement on behalf of all of the victims of abortion.

Your participation in a public pro-life awareness event or your presence at an abortion "clinic" or abortionist's office is an important affirmation of LIFE, exercise of your Constitutional right to free speech and assembly, and a witness against the tragedy of abortion. <u>You are the face of the unborn</u>.

Babies are dying at the hands of abortionists and their staff. Treat the site appropriately. Eating, loud talking and laughter are out of place.

- → Stay on sidewalks (public property). Do not go on the facility's property or parking lot.
- ----- Do not impede access of cars to/from driveways or pedestrians to doors or along sidewalks.
- Stay with a partner. Carry a camera and cell phone.
- Hold signs so they can be read by vehicle and/or pedestrian traffic. Don't wave signs in front of traffic. Hold signs tightly; larger ones should have handles or string to loop over the neck.
- Carry a pro-life pamphlet/card with pro-life assistance contact info.
- Praying, singing, and Scripture reading should be done without disturbing other pro-lifers who aren't joining your group.
- Do Not Shout at patients, workers, residents, those driving by, police, etc. Keep an arm's length away from them and step away from potential confrontations. Calling out to abortion-bound parents should be limited and done prudently; even though you're saying something positive, the stressed client may only "hear" negative screaming at her.
- Do not shadow (follow along closely) pedestrians.
- Respond to hecklers gently or not at all. Leave them with a positive life-affirming comment

Your prolife witness is seen by those contemplating abortion, those who know or will know someone with an untimely pregnancy, and those hurt by a past abortion decision. Your presence is critical in keeping the plight of the unborn on the public conscience and saving lives.
