Pro-Life News

At the January 2023 March for Life in Washington, DC, visitors to the National Archives reported that guards told them their pro-life gear would "incite others" and was not allowed. Pro-lifers at a table by the Washington Monument were told they were in a "First Amendment-free zone" and had to move. Pro-life visitors to the Smithsonian National Air and Space Museum were told to remove their pro-life hats or leave. The guards claimed the museum was a 'neutral zone'.

A leaked internal memo from the Richmond, VA FBI office warned of "radical traditionalist Catholic ideology" and of possible violent extremism among this sub-group, as distinct from standard 'Latin Mass Catholics'. The memo was inspired by the discredited "hate group list" of the Southern Poverty Law Center, and was withdrawn, for 'not meeting Bureau standards.' But an FBI agent told House Select Subcommittee hearings that a "tag" created to track post-*Dobbs* violence was all about tracking pro-lifers, not the people protesting at SCOTUS Justices' houses or attacking pro-life organizations and churches. When questioned about the violent attacks on pro-life pregnancy centers and pro-life churches, Attorney General Garland told Senate hearings that few people had been arrested because such violence happens "in the dark."

Pro-lifer Lauren Handy, one of the 10 defendants in the Washington, DC Surgi-Center case alleges an FBI informant, 'Eric Mike Santos,' recorded a recent meeting of her organization (PAAU) and used the tape to trap her. PAAU stated that at a recent hearing prosecutors used the recording to claim she had violated the terms of her release in the ongoing case.

Dennis Prager decried the mid-February "Repro-Shabbat." Led by the National Conference of Jewish Women, services at 1200 synagogues touted the notion that Judaism is okay with abortions for any reason, up to birth.

The Abortion Pill

MayDay Health, a nonprofit focused on promoting the abortion pill, launched a mobile billboard campaign on March 1st, targeting cities and college campuses in states with stricter abortion laws. The billboard advertised the MayDay website, which contains information on how to access abortion pills by mail without visiting a clinic, and states abortion pills "are a safe option to end pregnancy in the first 12 weeks." Taxpayer-funded National Public Radio promoted the campaign. Caroline Wharton of Students for Life of America stated, "This campaign is incredibly dangerous as it encourages the use of chemical abortion pills which kill a preborn child and leave women at risk of injury, infertility, domestic abuse, and death – and the campaign isn't even promoting the FDA-approved use of these deathly drugs as they extend the gestational limit further than considered safe by the HHS…It is very interesting that these trucks are being rolled out in time for Women's History Month because the early suffragists in our country who fought for women's civic equality were pro-life."

Slate recently published an article by Mark Joseph Stern and Dahlia Lithwick entitled "Dobbs was Always Just the Beginning." They stated, "Medication abortions are 18 times safer than childbirth, very reliable, and easy to access." However, between 2000 and 2019, the FDA collected 6,158 pages of adverse event reports on mifepristone. In addition, FDA rules changed in 2016 requiring that only deaths needed to be reported. According to the data, women with unknown ectopic pregnancies were at particular risk for severe complications or death. 20 deaths were reported, and 529 cases were described as "life threatening". The peer-reviewed *Issues in Law and Medicine* journal (ILM) warned, "the FDA AER (Adverse Events Reporting) system is inadequate and significantly underestimates the adverse events from mifepristone…significant morbidity and mortality have occurred following the use of mifepristone." Two other studies from California and Finland showed that a woman has four times the risk of developing complications from a chemical abortion compared to a surgical abortion. Data is incomplete or missing, as there is a tendency for abortion providers to instruct their clients to hide the use of the abortion pill from doctors/emergency room staff. In October 2022 the FDA warned that mail-order abortion drugs can result in serious side effects, and providers should not be writing advance prescriptions before a woman is pregnant, as this practice is potentially dangerous.



FEDERAL LEGISLATION

As of March 6, **HR.26**, *the Born-Alive Abortion Survivors Protection Act* still awaited further Senate action. Its companion, **S.204**, sits in the Senate Judiciary Committee. **Introduced pro-life Bills**:

HR.384 & **HR.1143/S.196** - To prohibit declaring a Federal public health emergency regarding abortion (to ease restrictions)

HR.427/S.95 - SAVE Moms and Babies Act: to ban new abortion drugs and tighten regulations on existing ones. HR.429/S.187 - No Tax Breaks for Radical Corporate Activism Act: to disallow employers claiming a medical deduction if they pay the cost of an employee's "abortion travel."

HR.435/S.16- *Protecting Life on College Campus Act:* to ban Federal funds for any college/university that hosts or pairs with a school-based site that provides surgical or pill abortions.

HR.116- *Pregnant Women Health and Safety Act*: to set minimum requirements for abortionists & their facilities. There are no L.I. cosponsors for the 5 bills listed above. **To be introduced soon:**

The *Women's Public Health and Safety Act*: to allow states to opt-out of Medicaid-funded abortions.

Anti Life Bills

HR.561 *E.A.C.H. Act* (Equal Access to Abortion Coverage in Health Insurance) for all persons. The *Right to Build Families Act* (to prohibit state laws protecting embryos created for IVF) will likely be reintroduced.

NATIONAL AND INTERNATIONAL NEWS

In a case alleging ten people blocked the entrance to the Washington, DC Surgi-Center, U.S. District Court Judge Colleen Kollar-Kotelly said the *Dobbs* decision did not address the question of whether the 13th Amendment's prohibition of involuntary servitude might confer a "right" to abortion.

The Alliance for Hippocratic Medicine v. FDA lawsuit alleges the federal government "negligently approved" the abortion pill. Currently, only one side effect (death) is recorded. In addition, the recent approval by the Dept. of Justice to freely mail abortion pills nation-wide clearly violates the 150-year-old Comstock Act.

On February 1, twenty State Attorneys General sent a letter to seven drugstore chains, warning of prosecutions for violating state laws regarding the mailing of abortion pills. On March 3, Walgreens said it "...will distribute *Mifepristone* only in those jurisdictions where it is legal and operationally feasible." [See LN, March 2023, p3] This includes nine states where abortion is not banned. Pro-abortion forces are calling for a Walgreens boycott.

Governor DeSantis supports the Florida Attorney General's bid to end all state money going to abortion facilities. Mike Hugo, Chair of the Framingham, MA, Democratic Committee said Pregnancy Help Centers were dangerous because they could cause the birth of a disabled child that could cost taxpayers too much money. He subsequently stepped down from the post due to his "misstatement," after thanking the committee for defeating a motion to discuss his removal. He said his resignation would "eliminate any distraction from the important work" of the local committee.

On January 24, pro-abortion activists attacked students at a Texas RTL conference. One woman threw a burning smoke bomb at them.

Lifenews.com reports the pink-painted Jackson Women's Health Center, involved in the *Dobbs* case, has closed.

Lawyers for the undercover journalists who exposed Planned Parenthood's organ harvesting have filed for a retrial, claiming the RICO act was misused, and there were 5th Amendment violations.

TIME Magazine's list of 2023's Women of the Year includes Verónica Cruz Sánchez, headlined as a "... Mexican Activist...Helping Americans Defy Abortion Bans." Her organization started by distributing the abortion pill in Mexico. However, since the *Dobbs* decision the organization has expanded to the U.S.

After decades of enforcing its one-child policy, China is now desperate for women to have children, given the 'nosedive' in its birth rate. Having children is now a "matter of patriotic urgency."



NEW YORK STATE LEGISLATION

Of the five bills to further Governor Hochul's abortion agenda, A.361a/S.348b;

A.1060/S.1043; A.1709a/S.1066a; A.733a/S.1003a; and A.117/S.3230, all but the last one has passed in the NY State Senate. [See LN, March 2023, p3]

New York State's 'Boss Bill' states a person cannot be refused a job for opposing an employer's core mission. On March 2, U.S. Court of Appeals, 2nd Circuit, Judge S. Menashi ruled in (EMC Frontline) *Slattery v Hochul*, that forcing EMC to accept employees who condone abortion "... would cause the group as it currently identifies itself to cease to exist."

HEALTH & SCIENCE Abortion, Mother's Health, Ectopic Pregnancies, and Miscarriage



On 2/21/23 at LifeNews.com, Micaiah Bilger stated that abortion is never medically necessary. Dr. John Bruchalski, a former abortionist and founder of Tepeyac OB/GYN in Fairfax, VA, stated, "There are no advantages for a mother to end her pregnancy by an elective abortion, even in the most life-threatening circumstances. Elective abortions become more dangerous the further along in pregnancy, and that's when the majority of these health complications arise." The goal is to care for both patients - mother and preborn child. Killing the child helps neither patient. There are circumstances where an early induction is necessary to save the mother's life (such as infection and ectopic pregnancy). In the rare cases where chemotherapy is necessary to treat cancer in the mother to save her life, the child may die. But the intention in these circumstances is to save a life, not to end a life. Bruchalski said, "As an obstetrician-gynecologist who used to provide abortions early in my training, I know that intentional feticide is never necessary even in the worst-case scenarios."

Dr. Byron Calhoun, who treats mothers with high-risk pregnancies, said, "The baby may be delivered prematurely and die from that, but it is never necessary to kill the baby to save the mother's life. [For example,] the severe preeclamptic may be observed until the mother's medical condition requires delivery. Unless the mother is bleeding to death, severe heart failure, or septic; there is usually time to wait and see if the baby will make it to resuscitation age at 22+ weeks."

According to both doctors, the most life-threatening complications happen later in pregnancy when abortions are more dangerous for the mother. Inducing labor gives the preborn child a chance to live. It is also quicker than abortion. A C-Section takes one hour. A direct abortion after 24 weeks can take 2-3 days.

Mary E. Harned, J.D., and Dr. Ingrid Skop, F.A.C.O.G., did an extensive analysis of state abortion laws and found they do not restrict doctors from providing miscarriage care, treatment of ectopic pregnancies or saving women's lives even in the cases where the preborn child may die. The American Association of Pro-Life OB-GYNs created a video explaining that banning abortions does not prevent doctors from providing life-saving care to women who suffer miscarriages or ectopic pregnancies. In a miscarriage, the child has already died. A procedure is done to remove the remains of the dead child. In an ectopic pregnancy the intent is to save the life of the mother, not to kill the child. If nothing is done, both the mother and the child will die. The child may die because of the removal of the ectopic pregnancy, but the death of the child was never the direct intention. **Designer Babies/Human Genetic Modification** (HGM)

The International Coalition to Stop Designer Babies consists of groups from around the world. They are lobbying against human genome editing and have issued a demand for an international convention to ban human genome editing and human cloning. The Coalition stated, "HGM is medically unnecessary. Pursuing it is an act of extreme scientific irresponsibility, likely to result in enormously harmful consequences for individuals and for global society as a whole. Human cloning and HGM were banned in international human rights treaties and in many countries in the 1990s, primarily because of the terrible history of eugenics. We support this deeply-felt and principled international ethical consensus. New technical abilities to conduct HGM do not change that consensus. Designing children's genes runs counter to accepted basic visions of diversity and the inclusion and equality of all vulnerable individuals and minority groups. Rather than competitively genetically 'enhancing' children, we want to encourage a world that celebrates and accepts all individuals and groups of people and that does not rely on oppressive and biological determinist prejudices about what constitutes a 'better' human being. Allowing HGM would exacerbate existing social inequalities. It would be an act of scientific irresponsibility and, in a time of rising neo-fascism, of political irresponsibility as well. Like human cloning, HGM is referred to in international declarations and treaties as contrary to human dignity, because it reduces human beings to the status of designed and optimized consumer objects. There are a range of robust alternative methods for avoiding genetic conditions, so the only advantage of HGM would be for ensuring 100% genetic parenthood of the child. It can never be ethical to submit a child to the severe health risks of genetic modification for this purpose. We are also concerned about the exploitation of and health risks to those sourced for eggs for research to make HGM possible. We call upon the UN to create an international convention to permanently ban HGM and human cloning. For the sake of our children and of our common humanity we must not cross this ethical line." (Note: The use of the term human genetic modification (HGM) rather than 'genome editing' is deliberate. Scientists seeking to promote HGM use genome editing to "allay public concerns about creating designer children." HGM refers to the "genetic modification of human eggs, sperm, or embryos to create a person who is genetically engineered in all cells of their body and will pass on the genetic changes to their offspring. Genetic engineering of cells for purposes of treating a particular disease as, for example, skin, liver, or lung cells, which we do not oppose, is usually referred to as somatic gene therapy.")

The Third International Summit on Human Genome Editing took place in early March. Their website states, "it will continue a global dialogue on somatic and germline human genome editing. Major themes for discussion include developments in clinical trials and genome editing tools such as CRISPR/Cas9, as well as social, ethical, and accessibility considerations." Peter Shanks of Biopolitical Times is concerned that the summit may not be able to maintain a consensus on prohibition. He thinks the UK's Human Fertilisation and Embryology Authority "will seek to grab for itself the authority to decide whether the UK will overturn existing global policy consensus that heritable genome editing should remain off limits." The Wellcome Trust reproductive biology think tank released the results of a 'citizens' jury' which voted in favor of editing human embryos to treat serious genetic conditions. Rob Stein of NPR thinks the position of scientists is moving from a "firm no" to genome editing to "how can we do this safely?" Sheila Jasanoff of Harvard reflected that He Jiankui (jailed for modifying the genome of 3 children) "transgressed the limits. He's clearly outside the limits. And therefore, everything else is now open for grabs. And therefore the problem before us now is to make sure that we lay out the guidelines and rules." (Source: Michael Cook, Bioedge.org, 3/7/23)

GUIDELINES for PRO-LIFE PRESENCE at PRO-LIFE EVENTS and ABORTIONIST'S SITE

All public pro-life witnessing *MUST BE PEACEFUL*. This is legal nonviolent direct action. Public pro-life outreach is a statement on behalf of all of the victims of abortion.

Your participation in a public pro-life awareness event or your presence at an abortion facility or abortionist's office is an important affirmation of LIFE, exercise of your Constitutional right to free speech and assembly, and a witness against the tragedy of abortion. <u>You are the face of the unborn</u>.

Babies are dying at the hands of abortionists and their staff. Treat the site appropriately. Eating, loud talking and laughter are out of place.

- Stay on sidewalks (public property). Do not go on the facility's property or parking lot.
- Do not impede cars to/from driveways or pedestrians to doors or along sidewalks.
- Stay with a partner. Carry a camera and cell phone.
- Hold signs so they can be read by vehicle and/or pedestrian traffic. Don't wave signs in front of traffic. Hold signs tightly; larger ones should have handles or string to loop over the neck.
- Carry a pro-life pamphlet/card with pro-life assistance contact info.
- Praying, singing, and Scripture reading should be done without disturbing other pro-lifers who aren't joining your group.
- Do Not Shout at patients, workers, residents, those driving by, police, etc. Keep an arm's length away from them and step away from potential confrontations. Calling out to abortion-bound parents should be limited and done prudently; even though you're saying something positive, the stressed client may only "hear" negative screaming at her.
- Do not shadow (follow along closely) pedestrians.
- Respond to hecklers gently or not at all. Leave them with a positive life-affirming comment

Your prolife witness is seen by those contemplating abortion, those who know or will know someone with an untimely pregnancy, and those hurt by a past abortion decision. Your presence is critical in keeping the plight of the unborn on the public conscience and saving lives.


