



Dear Defenders of Life,

There are many ways you can support the pro-life cause - by prayer, by peaceful witnessing at abortion mills, by writing letters to the editors, by political action and by financial support. As Chair of the Long Island Coalition for Life, I am asking for your financial support at this time. The LICL is a completely voluntary organization. Its Board of Directors and committee members receive no financial compensation. All of your contributions go directly for pro-life work.

Education is the first and foremost purpose of the LICL. We have provided pro-life speakers at Long Island high schools and colleges. We have pro-life displays at street fairs. We have a presence at abortion mills where we distribute business-size cards in English and Spanish that provide crisis pregnancy help phone numbers and websites. Our biggest expense is the publication of Life News, an essential educational tool.

This past summer, our Educational Trust sponsored pro-life fly over banners seen on Long Island beaches with the message “**Preborn Lives Matter.**” Although only 13 percent of our population is African-American, the CDC says that 33 percent of abortions are of African-American preborn babies. That has resulted in over 20 million black preborn babies who have been killed since Roe v. Wade came down in 1973. The LICL has made efforts to reach marginalized individuals with our pro-life message who have been victimized by the abortion industry, especially Planned Parenthood.

The LICL has also sponsored lobby-bus trips to Albany to stop anti-life legislation such as abortion and assisted suicide bills. Sadly the Abortion on Demand Bill was passed in January 2019, but we are still fighting doctor-prescribed suicide bills, with the false, harmless sounding title, “Medical Aid in Dying.”

The historian, Hannah Arendt, once described Nazism as “the banality of evil.” By this, she meant that evil had been normalized in Nazi Germany. And of course, in our own country the evil of slavery had once been normalized. In the United States today, we average over 2,500 abortions a day, more than 60 million since the Supreme Court legalized abortion through all nine-months of pregnancy with its Roe v. Wade & Doe v. Bolton decisions in January 1973.

We in the pro-life movement are fighting against this normalization of the killing of pre-born babies through abortion and the killing of the elderly, the depressed, and disabled through doctor-prescribed suicide which will turn doctors into killers.

Please help us to continue our educational efforts to end this killing by contributing whatever you can afford so that together we can win this fight for all those who cannot defend themselves.

## FEDERAL LEGISLATION

The **death of Supreme Court Justice Ruth Bader Ginsburg** (RBG) gave rise to such tributes that one writer spoke of the ‘canonization of RBG’, while fearful feminists stocked up on IUDs, lest her successor ban the item. RBG’s successor, Justice Amy Coney Barrett (ACB), is on the high court already. She has been hailed as a new model of feminism. RBG had no doubt that women couldn’t be equal to men unless legal abortion allowed a woman to ‘walk away’ from an unwanted pregnancy (the way a man can). According to E. Bachiocchi, ACB lives a new feminism, where equality means women and men share the responsibilities children bring, in a mutually agreeable way (not walking away). Abby Johnson says she laments the times she, or others at PP, told women ‘if you have the kid, not the abortion’, you’ll never finish school or reach your full potential. At her Senate hearings, ACB was asked if *Roe & Casey* were “super precedent.” Citing legal scholars, ACB said it’s not judges, but the people (i.e.: politics) who decide that. When a Supreme Court case is so widely accepted that no serious effort is being made to undo it, that case is ‘super precedent’. Neither *Roe* nor *Casey* fit that definition. {See: politico.com 9/27 & bizpacreview.com 10/14}

The Supreme Court now has a clear majority of *originalists*. Since the 1950s, the Court had been dominated by justices who adapt the Constitution’s meaning to fit leftist policy. The Court this term will hear a challenge to ObamaCare, and three religious liberty cases regarding adoption agency limits, the RFRA act, and campus ‘free-speech zones.’

The **US Senate** failed to advance **S.3072**, which requires a woman to pick up abortion pills ‘in person’. A similar Executive Order is on hold, and SCOTUS refused to give the Order a quick review. The President also issued a ‘Born Alive’ Executive Order. It does allow some doctor discretion.

**49 House members** asked Attorney General Barr to investigate if Planned Parenthood broke the Partial Birth Abortion ban (based on covert videotapes).

The **Washington Post** reported **PP** now receives over \$70M more in Federal funding than when Trump took office due to Medicaid increases. *Lifenews.com* (Aug. 5) lists seven ways the Administration has cut PP

funds, including *Title X* cuts, but some changes were nixed by the Courts. (Biden has promised to restore taxpayer funding to PP on Inauguration Day.)

**Did medication used to treat the President’s COVID infection contain “cells from an aborted baby?”** The “antibody cocktail” was refined and tested using HEK 293T cells, which came originally from kidney tissue obtained in a 1973 abortion. *Regeneron Inc.* says the cells have been continually regrown in culture, and genetically changed, thus are no longer considered ‘fetal tissue’. The headline in *Lifenews.com* agrees with Regeneron. The Children of God for Life website calls HEK 293T cells “aborted fetal cells”.

The acting head of the **US Agency for International Development** announced an increased effort to ensure that no US foreign aid funds are used, in any way, for abortions.



## NEW YORK STATE LEGISLATION

It is possible for the NYS Legislature to be called back into a late-year Special Session - usually for budget matters. However, other bills can be brought up. The following bills are currently in committee. Once the new session starts in January, bills will receive new numbers.

**S.1383/A.3130** Unborn Victims of Violence Act – Currently if a pregnant woman is violently attacked in NYS and her child dies in utero, no charges can be brought for the death of the child. 38 states, including California, allow for double homicide charges, but not NYS. This bill would change that.

**S.5332/A.7816** The Born-Alive Abortion Survivor’s Act would restore protections for babies who are born-alive during a late-term abortion. These protections were repealed with the enactment of the 2019 abortion law (RHA).

**S.3947/A.2694** Physician Assisted Suicide – This bill allows doctors to write lethal prescriptions for patients who are diagnosed as terminal and wish to take their own lives.

**S.5089/A.4831** Public University Emergency Contraception Education Act – This bill addresses ‘emergency contraception’ pills, such as Plan B. They are intended to be used within 72 hours of sexual activity. Although called ‘contraception’ they can work by preventing implantation, meaning they can cause an early-stage abortion.

**A.8743** – This bill would require all SUNY and CUNY campuses to stock and provide abortion pills in health centers on campus.

### Conscious Human Brains in a Petri Dish?



Wesley J. Smith reported at National Review (10/29/20), “As society roils with COVID and the election, the biotechnological revolution rushes forward with scientists bound by few enforceable ethical boundaries. As a consequence, we have already seen babies born who were genetically engineered, the march toward three- (or more) parent embryos, and increasingly radical proposals for creating novel family forms. Now, the prospect of growing *human brain* “organoids” from stem cells in a dish *that could become conscious*. Brain electrical activity has already been observed in the experiments. And now, some scientists are contemplating the next step.”

A Nature.com article (10/27/20) entitled “*Can lab-grown brains become conscious?*” reported on the work of researcher Alysson Muotri at the University of California, San Diego: “In [Muotri’s] laboratory, hundreds of miniature human brains, the size of sesame seeds, float in Petri dishes, sparking with electrical activity. These tiny structures, known as brain organoids, are grown from human stem cells and have become a familiar fixture in many labs that study the properties of the brain. Muotri...has found some unusual ways to deploy his. He has connected organoids to walking robots, modified their genomes with Neanderthal genes, launched them into orbit...and used them as models to develop more human-like artificial-intelligence systems. Like many scientists, Muotri has temporarily pivoted to studying COVID-19, using brain organoids to test how drugs perform against the SARS-CoV-2 coronavirus...In August 2019, Muotri’s group published a paper in *Cell Stem Cell* reporting the creation of human brain organoids that produced coordinated waves of activity, resembling those seen in premature babies. The waves continued for months before the team shut the experiment down. This type of brain-wide, coordinated electrical activity is one of the properties of a conscious brain. The team’s finding led ethicists and scientists to raise a host of moral and philosophical questions about whether organoids should be allowed to reach this level of advanced development, whether ‘conscious’ organoids might be entitled to special treatment and rights not afforded to other clumps of cells and the possibility that consciousness could be created from scratch...Other experiments, such as efforts to add human neurons to mouse brains, are raising questions, with some scientists and ethicists arguing that these experi-

ments should not be allowed. The studies have set the stage for a debate between those who want to avoid the creation of consciousness and those who see complex organoids as a means to studying devastating human diseases. Muotri and many other neuroscientists think that human brain organoids could be the key to understanding uniquely human conditions such as autism and schizophrenia, which are impossible to study in detail in mouse models. To achieve this goal, Muotri says he and others might need to deliberately create consciousness.

“Researchers are now calling for a set of guidelines, similar to those used in animal research, to guide the humane use of brain organoids and other experiments that could achieve consciousness. In June, the US National Academies of Sciences, Engineering, and Medicine began a study with the aim of outlining the potential legal and ethical issues associated with brain organoids and human-animal chimeras. The concerns over lab-grown brains have also highlighted a blind spot: neuroscientists have no agreed way to define and measure consciousness. Without a working definition, ethicists worry that it will be impossible to stop an experiment before it crosses a line.”

Wesley J. Smith commented, “Once the nausea abates, isn’t that a prospect we should grapple with on an international basis (with alacrity) to determine what, if any, regulations and legalities should be constructed around research with human brain cells? ...scientists are already introducing human neurons into mouse brains. What if these mice develop human-type awareness? Unfortunately, our leaders are failing us. As far as I know, even though biotechnology is the most powerful and potentially life-altering force since the splitting of the atom, [most world leaders have] never addressed the question. “The scientists” wring their hands but tend to oppose legally binding regulations. So, we are stuck with mostly voluntary guidelines and modest funding restrictions. That’s woefully insufficient. As we have seen, guidelines are meaningless unless they can be enforced with substantial penalties for their violation. But we don’t even know yet what to consider unethical. The excuse for such research to careen ahead is always the fight against disease. But that is not where these studies would end, not by a long shot. Some researchers are appalled by the current trends. Others, such as Muotri, are indifferent.”

The Nature article concluded, “...Muotri sees little difference between working on a human organoid or a lab mouse. “We work with animal models that are conscious and there are no problems. We need to move forward and if it turns out they become conscious, to be honest I don’t see it as a big deal.”” Smith reflected, “That crass attitude illustrates the huge peril biotech could pose to human decency. As the great moral philosopher Leon Kass once wrote, “shallow are the souls that have forgotten how to shudder.””



**Ever-Expanding Culture of Death:** Bioethicist Wesley Smith stated recently, "Once a society accepts the noxious notion that killing is an acceptable answer to human suffering, the definition of 'suffering' never stops expanding." Fr. Shenan J. Boquet of Human Life International wrote, "Smith was writing specifically about euthanasia. But the same logic underlies the whole culture of death. The culture of death is a ravenous beast. There is never enough death to sate its appetite." Fr. Boquet noted that abortion advocates always start with the 'hard cases' (rape, incest and threat to the mother's life) "to address the horrific suffering of the victimized women. Inevitably, the instant the door is open a crack, pro-abortion activists break through it with a battering ram. Law creates culture. And pro-abortion law inevitably creates a culture of coercion. The exact same thing is true in the case of euthanasia." Fr. Boquet refers to euthanasia and assisted suicide as "the poisoned fruit of abortion." (hli.org, 10/26/20)


