## FEDERAL LEGISLATION

Rather than laws being passed by Congress, most of the ‘action’ currently consists of Executive Orders, bureaucratic regulations, or Judicial decisions.

The US Supreme Court will rule in June on two cases where conscience protection clashes with either government-compelled speech (*NIFLA v. Becerra*) or customer-compelled ‘expressive actions’ (*Masterpiece Cakeshop*). Both are being argued, at least in part, as violating the protections of the 1<sup>st</sup> Amendment Free Speech Clause. California’s FACT Act forces Pregnancy Help Centers (like NIFLA) to post signs telling women where they can get state-funded abortions, thus forcing NIFLA to advocate against its core mission.

Tom Ascik (*crisismagazine.com 3/19/18*) points to several pro-free speech SCOTUS decisions over the past 44 years, even on ‘controversial’ subjects, as reasons to be hopeful: *Wooley v. Maynard* (1974) said a Jehovah’s Witness could cover part of a state motto on their license plate. SCOTUS threw out a law against certain hate symbols due to ‘viewpoint discrimination’ in *RAV v. St. Paul* (1992). *Hurley v. GLIB* (1995) held that Boston’s St. Patrick’s Day Parade organizers had a 1<sup>st</sup> Amendment right of ‘what not to say’. *Reed v. Gilbert* (2015) said a law allowing churches to post only small, one-day-only directional signs was a ‘content based’ restriction. These four decisions were unanimous. A 6-2 decision (*Ag. Intl. Dev. v. Alliance*, 2013) ruled Congress can’t require groups receiving foreign aid grants to have a policy opposing prostitution and sex trafficking. However, Congress could say no federal monies for those two purposes.

Many ‘friends of the court’ briefs have been filed. The US Justice Dept. supported NIFLA. In addition, 144 Congressional members supported NIFLA (all but one GOP; none of the NY representatives signed on). The brief backing *Becerra* was signed by 101 Congressional Democrats including LI Rep. Rice.

US District Judge Tanya Chutkan ruled twice last year that four pregnant unadmitted minors in government shelters must be permitted to get abortions. The ACLU has been fighting the Office of Refugee Resettlement’s (ORR) pro-life policy regarding these Jane Doe teens. On 4/2/18, Judge Chutkan approved the ACLU’s petition for a class-action suit against ORR, even though none of the minors currently in government custody seeks to end her pregnancy via abortion. The suit names ACLU to represent “all pregnant, unaccompanied immigrant minor children who are or will be in the legal custody of the federal government.” On 4/3/18, Judge Chutkan issued a preliminary injunction against ORR’s pro-life policy, and on 4/17/18 ordered written notice be given to “all unaccompanied minors” (male/female, pregnant/not), explaining their ‘right to abortion’. This notice must include the contact information for the ACLU. The

administration will appeal. Judge Karen Henderson dissented from the first Jane Doe case last fall, citing numerous rulings that these individuals do not have 5<sup>th</sup> Amendment Due Process rights, nor any others listed or unlisted in the US Constitution.

**HR 4712**, the Born-Alive Abortion Survivors Protection Act still awaits Senate action after passing the House in January. House action is still needed on the **Conscience Protection Act, HR 644**, which was introduced in 2017.

The 9<sup>th</sup> Circuit will allow Judge Wm. Orrick to continue presiding over the trial of videographer David Daleiden, despite Orrick’s close ties to Planned Parenthood. The US Dept. of Justice has been quietly probing PP’s alleged selling of aborted baby parts for the past several months.

The new White House Faith and Opportunity Initiative will give religious people and organizations a seat at the policymaking table. It will report on religious freedom exercise and protection, government/faith-based pairing, and government policy impact on religious organizations.

41 Senators, 153 Representatives, and 100 pro-life groups have asked HHS Sec. Alex Azar not to give any more money to Title X funds to organizations that perform abortions.

- A.1748 Glick / S.2796 Krueger** – late-term abortion expansion.
- A.1378 Cahill / S.3668 Bonacic** – comprehensive contraceptive coverage, including ‘emergency contraception’.
- S.3148-A Savino / A.2646-A Simotas** – mandated insurance coverage for IVF procedures.

**Abortion: A Calamity of the Greatest Magnitude** by Gerasimos Copoulos  
(2018 First Place LI Coalition for Life Oratory Contest Winner)

In the few seconds it took me to come up here to speak, on average about 12 unborn children were killed somewhere in the world. About two more suffer that same cruel fate with every passing second. I'm not sure it's possible for anybody to truly understand the depth of such a massacre. Every time a clock ticks, a unique life, one that could have had as much adventure, joy, and fulfillment as any of our own here today, is extinguished.

Make no mistake: what is happening over once per second around the world, or about three times a minute in the U.S. alone, is murder. No matter what your worldview, background, or creed is, that is the truth that anybody can derive from an honest examination of scientific and ethical facts - such as: From the very moment of conception, a new human is created. His or her DNA is distinct from that of his or her parents, and he or she fulfills all of the scientific biological requirements for life. At a fundamental level, it is simply inherently wrong to kill an innocent member of our own species, but many try to claim that an unborn child should not be afforded this right due to a lack of what they call "personhood."

What this objection fails to consider is that the main offense of the act of murder is the removal of one's future, the obliteration of experiences that a person could have very well wanted to live out. That's why the act of killing another person, even if that act is done painlessly and when the victim is temporarily unconscious, is inarguably wrong.

When one realizes this, one must also accept that the future of an unborn child has real and objective value, just like anyone else's. Hard-to-pin-down concepts like current "personhood" are totally irrelevant. Some may reply to this saying that an unborn child's future is merely theoretical, that because a fetus may only potentially become an adult one day, it has no value - but a fetus *will* become an adult, barring outside intervention or rare accidents. In that sense, an unborn child's future is only as theoretical as our own; nobody can truly guarantee that they will even live to see the sun rise tomorrow morning. Anyone's future is, by definition, only hypothetical.

Attempts to address this truth by citing a woman's bodily autonomy utterly fail to account for the fact that the only reason an unborn child exists is, in 99% of cases, due to a willful act on the part of the parents. Sex is an act that has natural consequences, and trying to lessen the probability of those consequences occurring doesn't excuse you if they still do.

When one speaks with someone who was nearly aborted, or survived an unsuccessful abortion, the argument that an unborn child is worthless seems patently absurd. If I may momentarily speak a bit more personally, my own mother is one such person. Her mother, my grandmother, was going to abort her due to financial concerns, but - thank God - she changed her mind at the last minute and backed out from her appointment. Had that last minute change of mind not occurred, my mother would never have been able to fully live. I would not be here to deliver this speech. For my mother and those like her, the idea that one could have been aborted is not a mere thought experiment which one can ponder academically without any sense of urgency or emotion. It's real, and it's terrifying. It is so easy for each of us to recognize that our own futures have value. Why then is it so hard to accept that the same is true for the unborn?

The sad answer is: it is inconvenient for many to admit that. A survey conducted by the Alan Guttmacher Institute (a pro-choice organization) in 2004 showed that over 75% of abortions were conducted because the mother felt she wasn't ready for a baby, had enough children already, or feared that having a child would be a financially risky decision. I do not mean to downplay the difficulty that mothers who seek an abortion face, but at the same time I cannot accept these as valid reasons to end a life. You cannot kill somebody simply because you feel that his or her existence impedes upon your happiness. It seems harsh, I know, to label these reasons for getting an abortion as being mere "convenience," but that terminology is not inaccurate. Those who get abortions for these reasons are prioritizing their own quality of life over the actual lives of their unborn children, and this cannot continue if we have any desire at all to be a morally upright society.

Those who support abortion claim that banning it would lead to a dystopian future in which women have no choice but to seek illegal abortions. I have a far more optimistic vision of the future. Through human love and support, and a real push to put in the hard work needed to solve this problem, not only can we save countless children from a cruel death in their mothers' wombs, but we can also work to help the lives of impoverished mothers who might turn to abortion when they feel that they have no other options. As long as we stand together and never cease arguing, discussing, and opposing abortion, we can defeat this moral abomination both in its practice and at its source. *We must*, for this is the most important moral issue of our lifetimes. Failure is not an option. Thank you.


