In the New York State Legislature, we are presently fighting so called, medical-aid in dying bills which is really doctor-prescribed suicide (DPS). Remember the slippery slope we have gone down with abortion legislation. At first we were told abortion would only be necessary for the hard cases when a mother's health and life was at serious risk. However, abortion is now legal for any reason through all nine-months of pregnancy. The same outcome will likely occur with DPS. At first the law will apply only to the terminally ill which will be defined by some arbitrary time-limit like six months, but as time goes on DPS will eventually be expanded to include the mentally ill, physically disabled and the elderly. It is vital that we understand that support for Doctor Prescribed Suicide will lead to acceptance of euthanasia. These two topics are inextricably linked. Once you declare the purpose of DPS is to end suffering, there is no limiting principle because suffering is part of the human condition and comes in many different forms and degrees. This outcome is exactly what has happened in Belgium, the Netherlands and Canada. For further information on end-of-life issues, contact Patients Rights Council at www.patientsrightscouncil.org.

Will depressed patients feel they have a real choice given the emotional and financial costs they are imposing on their families? They will feel they have a duty to die and are being selfish by choosing to live. We need your support to stop such anti-life laws. FEDERAL LEGISLATION

Congress passed the *Pregnant Workers* Fairness Act as part of a \$1.7T spending bill in 2022. The Act says employers must allow time off or alter job duties for workers with "limitations related to...pregnancy, childbirth, or related medical conditions." Last October, the Equal Employment Opportunity Commission proposed rules to implement the

Act, with 30 days for comments. On April 15, the EEOC's rules were released. The rules say the Act extends to women who abort or use artificial birth control, with no exemption for religious employers. Firms with under 15 workers are exempt. The EEOC rules will take effect on or about June 18. Texas filed suit in 2023, saying the \$1.7T bill was unlawfully passed.

The **Federal EMTALA** says a patient coming to an ER must get "necessary stabilizing treatment". If an ER doctor says that means performing an abortion, can it be done in a state banning most abortions? The US Supreme Court heard oral arguments in the case in April. A decision will likely be released in late June.

In April, former Pres. Trump said he would not sign a national abortion ban law. *Dobbs* gave the voters and legislature of each state the power to set abortion laws. Trump agreed, adding he supports the usual three exceptions.

John D. Davidson (thefederalist.com 4/11) says that Trump's position on abortion mirrors, in many ways, the view of Sen. Douglas in the Lincoln/Douglas debates - each State should decide if it is Free or Slave. It might be politically savvy (short term), but as Lincoln said, it means one group of people can strip the Rights from another group of people, if the first group voted to do so. (That is tyranny, not self-government.) Current-day Democrats' view of abortion parallels southern slave-owners - the constitutional rights of an entire class of people (women) depend for their vindication on the denial of all rights to another class of people (the unborn). However, this is about First Principles (life & liberty), not Politics.

Also, at the federalist.com, J. Boyd wrote that protections at the Federal level have always been a Pro-Life goal, and Trump's mixed messaging on abortion and IVF helps activists use scare tactics to codify abortion.

Independent Presidential candidate Robert F. Kennedy, Jr. told Ben Shapiro he believes the decision to abort a child in the eighth month of pregnancy is morally "nuanced and complex." Shapiro asked, "what about the baby's 'bodily autonomy'?" RFK said "... I understand that position, and I don't agree with it."

Politicians from all parties are promoting bills to 'protect' IVF. However, 3 Congressmen. - Brecheen [OK], Clyde [GA] and Rosendale [MT] sent a letter to the CDC, calling our IVF industry the 'Wild West' compared to other countries. By May 29, they want CDC data for how many embryos are created, frozen (kept for how long) and discarded yearly. How many are genetically tested, and do the tests alter the embryo's fate? Are there CDC target numbers for any of these acts, or how to treat/destroy nonimplanted embryos? An IVF clinic says they make 7 or 8 embryos per patient. The CDC says over 238,000 woman tried IVF in 2021 (resulting in 1.6M to 1.9M embryos). Yet under 100,000 were brought to term, meaning 1.5M to 1.8M either failed to develop or implant, were frozen, or destroyed. Yearly, the IVF industry could end nearly twice as many human lives as abortion. (About 985,000 abortions were committed between July 2022 and June 2023.)

NEW YORK STATE



The NY Court of Appeals (NY's highest state court) heard oral arguments on April 16 in a case challenging **NY's abortion insurance** court) heard oral arguments on April 16 in a **mandate.** In 2017, the state mandated that

abortion be covered without copays, coinsurance, or deductibles for anyone whose medical insurance is governed by NY law. The mandate was codified by the Legislature in the 2022-2023 state budget. The very narrow "religious" employers" definition excludes faith-based charities and other employers who object to paying for abortion coverage. Attorney Michael L. Costello argued "the mandate plainly burdens the Religious Objectors' [First Amendment] religious exercise, as it requires them to provide coverage for abortions – an act they consider a grave sin."

At the end of April, NY Attorney General Letitia James served a dozen pregnancy help centers with a "Notice of Intention to Sue." She is accusing the centers of "repeated and persistent misleading statements and omissions' regarding Abortion Pill Reversal (APR). James alleges the pregnancy help centers use false and misleading statements to advertise APR, and accuses them of fraud, deceptive business practices, and false advertising, claiming they are "spreading dangerous misinformation." She gave the centers 5 days to respond to why they shouldn't be charged with "false advertising." They face \$5,000 fines for every violation – every time they take a phone call from a desperate pregnant woman, or any public statement regarding APR. On April 30, The Thomas More Society sued James to block her threatened legal action. On May 1, The Thomas More Society followed up with a request for preliminary injunction against the Attorney General.

Medical Aid in Dying Act (MAID) Bills S2445A and A995A: The purpose of the NYS "Medical Aid in Dying" bill is "To provide that a mentally competent, terminally ill patient may request medication to be self-administered for the purpose of hastening the patient's death." The bills are currently in the NYS Senate and Assembly Health Committees. Pro-lifers do not want them to reach the floors of the Senate and Assembly for a full vote. Doctors must lie on the death certificate, listing the underlying illness as the cause of death instead of suicide. A mental health evaluation is not required unless specifically ordered by a physician. Advocates for the disabled are concerned they will be pressured or coerced into suicide.

Editor's Note: As this newsletter was going to print, a New York judge ruled that the proposed Equality Amendment can not appear on the ballot in November. The judge ruled that the legislature approved the language of the amendment before Attorney General Letitia James could provide a written opinion on the proposal. The legislature voted on the amendment before either getting the opinion, or waiting the required 20 days before voting without an opinion. Democrats said they will appeal the decision, and get a reversal of the ruling, as there is not time to start the amendment process over again before November.

JMJ The Truth about Abortion

"My Body; My Choice; Abortion Rights are Human Rights; Abortion is healthcare." These are all lies spewed by the abortion industry by which they entrap women. They promote the idea of a safe environment that especially cares for the women and her wellbeing. However, this is far from the truth. Marion was only 17 when she became pregnant. Being from an unstable home and without any support, she was forced to have an abortion by her mother. She had even sought safety at Planned Parenthood by revealing her fears and pressure. However, these fears were ignored by the clinic, and she went through with the abortion. It's cases like these that make me wonder why abortions are advertised as "empowering", by sayings like "My body my choice." Because Marion never had a choice, and her child certainly did not. When it comes to these unplanned pregnancies, women are coerced to believe, just as Marion was, that they are without any support, leaving Abortion the only option.

It is a scientific fact that at conception, the child's own DNA and unique genetic makeup are present. At the seventh week, a heartbeat can be detected, and by the twelfth week, the child's nervous system is developing, meaning the child can then feel pain. Babies have even been seen on sonograms trying to flee away from the abortion instruments. So how can there be any doubt abortion is the <u>intentional killing of a human life</u>. And how can people justify this horrible crime of abortion as women's healthcare? The abortion industry gives the idea that abortion is here to support and empower women, by convincing them this isn't murder, that it's their right to decide, their right to healthcare.

But this isn't really about women's healthcare or empowerment. The Founder of Planned Parenthood, Maragret Sanger, promoted the ideology of a superior race, eugenics, proclaiming, "We want a world freer, happier, cleanerwe want a race of thoroughbreds. "She even goes further with her discrimination, by specifically placing Planned Parenthood clinics in predominately poor and minority neighborhoods. For as she claimed, "People of color are like human weeds that need to be exterminated." Sanger used abortion and birth control not to empower or support women, but to mask the true purpose behind Planned Parenthood.

Although this organization now tries to distance themselves from Sanger, Planned Parenthood still target minorities. According to Protecting Black Life, 78% of all Planned Parenthood clinics are in minority neighborhoods. According to Black Dignity, the black population has decreased by 25% due to abortion since 1973. Furthermore, in their own 2021-22 Annual Report. Furthermore, out of the 9 million services provided by Planned Parenthood only 0.06% were prenatal services, and 35% of the total revenue was funded from government health services reimbursements and grants.

Beginning in 2023 the FDA lifted restrictions concerning the abortion pill. They now allow women to take this pill without an in person visit with a doctor. But without these restrictions many more concerns have arisen. For without the need for an in-person visit, no sonogram is required. Therefore, these doctors have no way of truly knowing how far a mother is in her pregnancy, making this process even more unsafe to the mother. According to the FDA, 32 death and several cases of fatal sepsis have occurred as side effects of this pill, as well as severe cramping and bleeding. All of this boils down to the fact that although Planned Parenthood may preach about safety, they carelessly prescribe this pill knowing it may endanger a women's own life. Because abortion is not about support, compassion, or healthcare; it's a business with an agenda, which sadly thrives at the expense of young and afraid women. By legalizing abortion, women are stripped of the singular privilege- the privilege of bringing a child into this world.

But there are options for these women out there. Institutions like Hope Clinic, Life Center of Long Island, Birthright and many more, are Pro-Life, and provide counseling whether the mother had an abortion or not. These organizations, provide free pregnancy tests, ultrasounds, abortion reversal pills, and supplies. But most important, they provide adoption guidance and referral. When it comes to adoption most mothers believe it is too expensive and traumatic to carry a baby full term to then just give it up. However, according to DPA, Deconess Pregnancy and Adoption, choosing adoption is less expensive since the adoptive family covers the cost. Whereas for an abortion the money is strictly the women's responsibility. In addition, giving up the baby can lead to greater happiness on behalf of the mother, knowing that her baby will be well cared for and loved. Within my own family, my grandparents adopted two beautiful baby girls who I now look up to for guidance. I am forever grateful to these mothers for deciding to choose life, for I now have two beautiful aunts.

We the pro-life generation must be the voice of these innocent children who never had one. We must show our support and compassion to these women, such as Marion, who could never stand up against the illusion that abortion was the only choice. By volunteering at pro-life clinics, attending marches for life, voting pro-life and most important by educating women about the beauty of choosing life and the horrors of abortion, we can truly make a difference in the pro-life community. So let us be their voice and help these women choose life. Thank you.

WHAT THE MEDIA DOESN'T WANT YOU TO KNOW ABOUT THE "EQUALITY AMENDMENT"

In November 2024 a proposed state constitutional amendment, the "<u>Equality Amendment</u>", if approved by the voters, will create a state constitutional right to "**REPRODUCTIVE HEALTHCARE AND AUTONOMY**" for "**PERSONS**." Notably absent from its text are the words and phrases "MINOR," "PARENT," "CONSCIENCE," and "LATE TERM."

NYS Legislature bills: A.1203 and S.108A

"No person shall be denied the equal protection of the laws of this state or any subdivision thereof. No person shall, because of race, color, ethnicity, national origin, age, disability, creed, religion, or sex, including sexual orientation, gender identity, gender expression, pregnancy, pregnancy outcomes, and reproductive healthcare and autonomy, be subject to discrimination in their civil rights by any other person or by any firm, corporation, or institution, or by any agency or subdivision of the state, pursuant to law."

This "Equality Amendment" can empower unaccountable state judges and bureaucrats to:

- **DISCRIMINATE** against <u>BABIES</u>, **EVEN IN THE NINTH MONTH OF PREGNANCY**, by denying their right to life by endorsing their killing by abortion, including *painful late term abortion*, and by *infanticide through intentional neglect* if the baby is **born alive** after an attempted abortion.
- **DISCRIMINATE** against social workers, educators and health care workers, <u>INCLUDING DOCTORS</u>
 <u>AND NURSES</u> by denying them state licenses if they refuse to do abortion referrals.
- **DISCRIMINATE** against <u>PARENTS</u> by denying parents the right to require their consent for their minor age daughters being given an *abortion* while requiring the consent of parents for their minor age daughters being given an *aspirin*.
- **DISCRIMINATE** (IN FAVOR OF ABORTIONISTS) by awarding abortionists the PRIVILEGE of operating without the health and safety regulations lifesaving surgeons and pharmacists must adhere to.

This "Equality Amendment" can empower *unaccountable state judges and bureaucrats* to regulate, harass, fine and prosecute public pro-life witnessing and crisis pregnancy centers *out of existence* as violators of the "Civil Right" of "Reproductive Healthcare and Autonomy."
