FDA Changes RU-486 Protocol

On March 30th, the Food and Drug Administration changed the rules for administering a chemical abortion drug and endorsed abortionists' longstanding practice of ignoring previous federal guidelines. The FDA changed the regimen for mifepristone (Mifeprex), significantly reducing the obstacles, burden, and cost to abortionists. In 2000 the FDA set up guidelines which required the abortionist to administer 600mg of mifepristone, which causes the newly implanted child to detach from the uterine wall. The mother then takes 400mcg of misoprostol, which causes contractions to expel the baby. However, abortionists found that prescribing a lower dose of the expensive mifepristone and increasing the dose of misoprostol saved approximately \$200 per abortion. In 2008, the National Abortion Federation stated that only 4% of abortion facilities followed the FDA's guidelines. Chemical abortions have surged from 6% of all abortions in 2001 to nearly 25% of all abortions today. Randall O'Bannon, Ph.D., National Right to Life Director of Education and Research, stated that this new change in protocol came "despite a record of at least 14 known deaths, and thousands of women suffering." By 2011, there had been 2,207 cases of severe 'adverse events' including hemorrhaging, blood loss requiring transfusions, serious infections and deaths. The March 30th announcement approves mifepristone use 10 weeks into pregnancy. The previous protocol limited the use to the first 7 weeks. A 1998 study found that 9% of women who have medical abortions at 57-63 days gestational age will require emergency surgery. The new guidelines also allow personnel other than doctors to administer the pill. Troy Newman of Operation Rescue stated, "Extending the upper recommended gestational limit from 49 to 70 days only ensures that the risk of incomplete abortion will be multiplied, as will the number of women visiting emergency rooms around the country suffering from partial or failed abortions." Randall O'Bannon said, "Certainly none of the modifications are of any benefit to the unborn child. The FDA's new protocol serves only the interests of the abortion industry by expanding their base of potential customers, increasing their profit margin and reducing the level of staff and amount of resources they have to devote to the patient." Anna Paprocki of Americans United for Life stated, "While the abortion industry will falsely celebrate the label change as a green light to its practice of skirting regulations, it would be wise to remember that women and girls have been injured and killed by the abortion industry's flagrant disregard for the previous FDA label." Troy Newman added, "The FDA should be more about protecting the public from exploitative and predatory uses of drugs rather than pandering to Planned Parenthood and the rest of the Abortion Cartel."

Zika Virus

During the Congressional investigation hearing in March, pro-abortion witnesses claimed that a vaccine and cure for the Zika virus would require fetal tissue research. However, Dr. David Prentice of Charlotte Lozier Institute stated that there is no evidence that fetal tissue is needed. In fact, a 2012 Nobel prize was granted for a vaccine for another disease impacting preborn children using induced pluripotent stem cells which can be made from skin from an adult. "It's very similar to the Zika virus...[There is] a 100% effective vaccine against this similar virus. No fetal tissue at all was used. The scientists involved used monkey and mosquito cells, and it is the mosquito that is believed to be the culprit in Zika." Therapies have been developed using cell lines not of fetal origin including insulin for diabetes (produced in bacteria), Herceptin for breast cancer and tissue plasminogen activator for heart attack, stroke and pulmonary embolism (both developed in Chinese hamster ovary cells).

FEDERAL LEGISLATION

On March 29, days after hearing *Zubik v Burwell* (Little Sisters, Geneva Col., Priests for Life, etc.), the Supreme Court issued an unusual Order to all parties in the case. Due

April 20, it asks for more ideas as to how the plaintiffs employees could get coverage for HHS mandated items in a way that does not violate the conscience rights of their religious employers. Some Court observers see this as an encouraging sign.

Judge Merrick Garland is President Obama's Supreme Court nominee. He has little record on abortion, though he has praised the author of *Roe v Wade*. In Nov. 2014, he was part of a unanimous US Court of Appeals (DC Circuit) ruling that the HHS abortifacient/sterilization/ contraceptive Mandate does "not impose a substantial burden on Plaintiffs' religious exercise."

CORRECTION: Last month's column stated: "The Senate website states of the 160 (SCOTUS) nominees sent by Presidents to the Senate:....29 got no vote at all. About one out of five." The '29' figure was based on the webpage summary, simple math, and Radio reports. The full data paint a more complex picture. With the nomination of Judge Garland, there have been 161 *Nominees*, not 161 people. How? Example: Justice Roberts was supposed to replace O'Connor, but the Chief Justice position became open, so Robert's nomination was withdrawn and switched. It counts as 2 nominations. Some past Judges were nominated 2, or even 3 times. Of the 161 *nominees*, the Senate website says: '117 were confirmed & served; 7 Declined, (total 124). Stats for the other 36 *nominees*, (excluding Garland), are: Postponed 3, Rejected 12, Withdrawn 12, No Action 9. However, some Judges in the No Action or Withdrawn lists were later re-nominated, and some of them were confirmed. It appears that four individuals on the No Action list never did get a second chance. See: <http://www.senate.gov/pagelayout/reference/nominations/Nominations.htm#confirmed>

On March 30, twelve subpoenas were issued by the House panel investigating the 'fetal harvesting industry' - eight for documents, four for depositions, to begin in April.

On April 5, agents from the CA Attorney General's office raided the home of David Daleiden, seizing all his undercover aborted baby body parts videos, and his personal info. (*Lifenews.com* 4/06/16). CA State Attorney General Kamala Harris has received over \$81,000 in campaign contributions from several Planned Parenthood PACS. (*Lifenews.com* 4/07/16).

Fed. Legislation continued....

C-fam reports the UN is again pushing the 'Tobin Tax' on international financial transactions. It would raise billions for the UN, yet lack the usual 'strings' for money given to the UN by governments. The money is earmarked for 'humanitarian' purposes, but the UN puts abortion in that category, especially regarding Zika-affected women.

 NYC Bill 371-A forced Pregnancy Resource Centers (PRC) to post signs saying they don't do abortions, plus other onerous requirements. Two courts had struck down most of the law by Nov. 2014. On March 29, US Dist. Court (southern NY) clarified one last provision: All PRCs are allowed to give out Pregnancy test kits. *Medical* PRCs must have licensed professionals do (or oversee) specific medical services like ultrasounds, to avoid penalties. A California law, like 371-A, took effect Jan. 1, and is being defied by at least two PRCs. Austin, Baltimore, and Montgomery Co., MD had similar laws struck down.



NEW YORK STATE LEGISLATION

Proposed legislation in the NYS Senate and the Assembly, S.5814/A.5261-B and S.3685/A.2129-A, would legalize assisted suicide. As stated in last month's issue of *Life News*, Gov. Cuomo said he would want to carefully review the bills' details prior to making a decision whether he would support them, stating, "It's obviously complicated and controversial." **We must keep vigilant and stay informed on this matter.**

CRISPR-Cas9 Technology



Daniel Becker, president of Personhood Alliance, reported at *LifeSiteNews*, 1/15/16, "[In December 2015] a landmark conference in Washington, DC, the International Summit on Human Gene Editing, advocated deadly experimental use of children at an embryonic level of development for purposes largely related to curing certain genetic anomalies.

"Human Gene Editing (HGE) was formerly referred to as 'germline intervention'. HGE is the creation of a genetically modified human. HGE changes made to a human child at an embryonic level will be passed through normal sexual reproduction to all future offspring. This emerging technology has profound implications for the future of the human race. Advocates hope to bring generational cures to genetic diseases such as Sickle Cell Anemia and Tay-Sachs Disease which can be specifically targeted for HGE at an early embryonic level. Critics are arguing that the technology is too new and the inherent risks to all of human-kind are too great. Due to the uncharted concerns and very present unintended consequences regarding HGE, many scientists in the summit are calling for a moratorium on all human gene editing...Poor science and breaking the law are just a couple of the reasons why we should be concerned when discussing proliferation and scientific acceptance of this emerging technology...HGE has been condemned by the UN and outlawed in over 29 countries (China, North Korea and the United States are **not** among them). Due to its eugenic history, Germany has enacted some of the strictest penalties for human embryo experimentation.

To prevent the medical research community from repeating these [war] crimes, the Nuremberg Code was adopted by most western nations (**United States excluded**) and became the founding tenet of modern bioethics. If the embryo is a person, then HGE would be a violation of informed consent."

CRISPR-Cas9 is a technology used to edit the genomes of human embryos. In April 2015 scientists at Sun Yat-sen University in Guangzhou, led by Junjiu Huang, "published the first and only paper to date of this controversial form of human experimentation. This new genetic modification technology is called CRISPR, short for 'clustered regularly interspaced short palindromic repeats'. CRISPR is incredibly fast, relatively simple, and very cheap. A recent biotech startup named Amino has brought desktop bioengineering to everyone for a little under \$700.00. For less than the cost of a leading smart phone you can bioengineer your own glow-in-the-dark bacteria by splicing genes in your garage. Their marketing material boasts that "Amino is a small and simple-to-use hardware system that enables anyone to grow and take care of living cells. We are the world's first publicly available bioengineering platform that can be used at home, in labs, or in schools. These hand-assembled polished rich Mahogany Amino Ones are shipped with the Amino Glo App, a DNA program, and the set of chemicals needed to transform the regular bacteria into a glowing

organism and keep it growing and glowing! A living Nightlight!" Or Nightmare, according to Becker, "depending on whose hand holds the test tube. These do-it-yourself (DIY) bioengineering kits have been criticized as opening the door to "bio-hackers" who may use the technology for malevolent intent. From DIY DNA kits to community laboratories where CRISPR is available to untrained amateurs, the possibility for domestic bio-terrorism becomes a probability." Heidi Ledford, writing in the science journal *Nature* stated, "One of the biggest fears surrounding CRISPR is that it could be used to create a genetic modification designed to spread through a population of organisms at an unnaturally fast rate." Becker added, "The FBI routinely builds relationships within the bio-hacker community so that any real-time threat can be assessed and hopefully neutralized."

Becker concluded, "As the price of this 'cut and paste' gene sequencing has reached the hobbyist levels, the temptation to alter children at an embryonic level has proliferated. Testing material is easily acquired. An excess of over 500,000 human embryos have been created through the IVF process. Clients routinely abandon their cryogenically preserved offspring rather than continue to pay for the upkeep of their frozen embryos. It is increasingly common that they altruistically donate their 'leftovers' to science. With the easy availability of human test subjects whom the National Institutes of Health have declared non-persons, it is just a matter of time until a rogue scientist using CRISPR technology repeats what was done in China last April [2015] and produces a GMO child. Once the genie is out of the bottle there will be no putting it back. Perhaps we should heed science fiction writer Bruce Sterling, "Maybe we're about to radically change the operating system of the human condition. If so, then this would be a really good time to make backups of our civilization." Peter Saunders, Chief Executive of the Christian Medical Fellowship in the UK, reported on the CMFblog.org.uk on January 18, 2016, that Dr. Kathy Niakan of the Crick Institute in London made a case in early January to be the first in the UK to be allowed to genetically modify human embryos. Niakan wants to use CRISPR-Cas9 to edit genes in 'leftover' IVF embryos "in order to discover what role they play in normal embryo development. She plans to start with a gene called Oct4...using 20-30 donated embryos. If successful she plans to move on to testing 3 or 4 other genes, each using a further 20-30 donated embryos. No doubt further requests will follow once the principle has been established...International criticism is mainly driven by concerns about safety and unforeseen consequences - introducing genetic changes into a day old embryo will mean that any genetic change will be expressed in every cell of the developing human being, including reproductive cells (sperm and egg), and will, therefore, if implantation follows, be passed on down the generations."

Let us remember that in addition to the danger of passing down genetic changes through the generations, a human being is destroyed every time an embryo is used for research and discarded before implantation.


