The LICL sends out Candidate Questionnaires each election cycle so that we can better inform our readers of where the candidates stand on pro-life issues. This year, 109 were mailed (5 electronically) to candidates for US Senate & House of Representative, and for NYS Offices of: Governor, Lt. Governor, Comptroller, Attorney General, NYS Senate & NYS Assembly. The seven questions asked & the responses received as of printing of this issue of Life News are below. **NOTE:** Only the named candidates replied to our questionnaire.

**Candidate Questionnaire (CQ):**

1. Would you vote for legislation to protect innocent human life from conception to natural death?
2. Would you vote against use of taxpayer money to fund abortion?
3. Would you vote for Parental Consent for a minor seeking an abortion?
4. Would you vote for legislation requiring Informed Consent for a woman seeking an abortion?
5. Would you vote for legislation to prevent the legalization of euthanasia and assisted suicide?
6. Would you vote to ban all human cloning and research that destroys a human embryo for his/her stem cells?
7. Would you vote to deny taxpayer funding for Planned Parenthood?

Pro-life reservations with IVF funding include:

\*IVF most often results in the creation, freezing, discarding, and systematic destruction of embryos

\*greater numbers of embryos are implanted to increase the likelihood of at least one embryo surviving implantation; however, if 'too many' survive implantation, then 'fetal reduction' (abortion) is recommended

\*Pre-Implantation Diagnosis is often used to pick and choose embryos based on health, physical characteristics, and gender

\*Leads to the mentality to manufacture the best 'product' most efficiently, and to 'throw away' the ones that fail 'quality control'



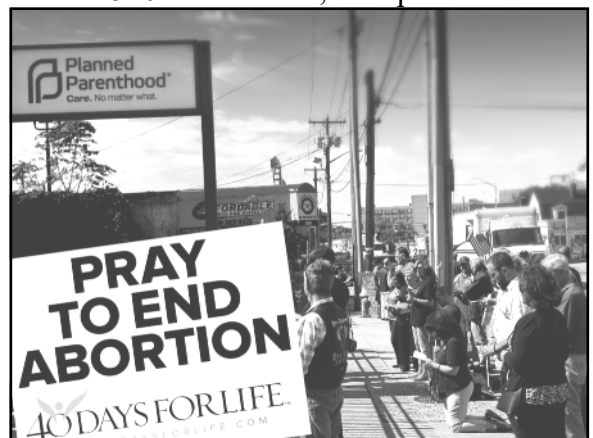
