### Surgeon General David Satcher—Another Planned Parenthood Mouthpiece

Planned Parenthood's (PP) "local educator", Suzanne Witzenburg, in a letter to NEWSDAY, 7/19/01, lauded the Surgeon General's report of July 2001 titled "Call to Action To Promote Sexual Health and Responsible Sexual Behavior" as a "voice of reason" and suggested we should emulate France's sex education programs at all grade levels, have easy access to contraceptives and school based clinics.

France has had an extensive confidential program of dispensing contraceptives in schools for over ten years. French health and education officials are now dispensing emergency contraception pills, hoping to reduce unwanted pregnancies among teens and lower the country's abortion rate, among the highest in the European Union. It has not dropped, despite the easier availability of contraception in the last decade. In the light of France's inability to address its own problem, it is hardly a model to be emulated.

David Satcher was appointed by President Clinton to succeed Joycelyn Edlers as Surgeon General. His July 2001 report was two years in the making. While the report attempts to address teen pregnancy, HIV/AIDS, unintended pregnancy and abortion rates, the report is at best problematic, not only because the solutions proposed are questionable but it also promotes a public health policy which endorses condoms, thereby promoting a false sense of security for teens. While it supports marriage it also endorses a policy to refrain from sex until a "mutually monogamous relationship" is achieved. One asks under what circumstances—or will any mutually monogamous relationship be acceptable.

The greatest failure of the report is that it does not address the issue of multiple sex partners. What David Satcher is really promoting is PP's agenda: freedom of sexual expression and contraception for all. This condom mentality is in keeping with PP's agenda and opposition to parental consent or notification of a minor seeking contraceptives, abortion or treatment of an Sexually Transmitted Disease (STD). The programs that are cited as models are community based programs, Peer and Health Educator Programs, school based clinics, comprehensive sex education -- right out of PP's manual.

It is incredible that the so-called prevention models continue to be cited as effective when they have failed to demonstrate a dramatic impact on STD's, pregnancy or abortion. Consider the following statistics:

--STD's infect some 12 million persons each year, 2/3 are under age 25.

- --774,467 AIDS cases, nearly 2/3 of which are sexually transmitted have been reported since 1981.
- --between 800,000 and 900,000 persons are living with HIV; ¼ are under age 22.
- --29% of all teen pregnancies end in abortion
- --nearly one-half of pregnancies are unintended

We have 3 to 4 million new cases of chlamydia (which can lead to infertility) and 5.5 million new cases of human papilloma virus (which can cause cervical cancer) each year for which condoms are ineffective. Those most affected are 15 to 19 year olds. Currently, there are 10 to 12 million new cases of STD's reported each year. Our government has spent 230.8 million of our taxes on STD prevention and \$7.5 billion on treatment. The most glaring omission in Satcher's report are abstinence programs which have demonstrated dramatic results, some of the most successful are as follows:

- -- The Best Friends Program, Washington, D.C.
- --Michigan Abstinence Partnership
- --STARS Program-Oregon
- -- Tennessee Study
- --South Carolina's Community Program
- --National Longitudinal Study on Adolescent Health, AMA, September 1997

All of these demonstrably successful programs, dating back to 1981, were dismissed by Satcher as needing "more research"

Leslie Kantor, spokesperson for the Othmer Institute at Planned Parenthood of New York bemoaned the fact that our government is spending \$100 million for abstinence only programs. Over the past eleven years, PP has received \$1.6 billion from Title X Family Planning from Federal and State tax revenues. What do they have to show for it? Increased out-of-wedlock births for sexually active teens, increases in STD's and too many teen abortions. Satcher's report, in the final analysis endorses conclusions which he has long held and supported by PP as well. In 1994 when Satcher headed the Center for Disease Control and Prevention he ran an \$800,000 national advertising campaign aimed at America's youth. One ad helpfully read "Latex condoms are available in different colors and textures. Find one that's right for you."

What to do? Call the White House comment line (202-456-1111) and ask that President Bush demand an immediate resignation from Surgeon General David Satcher. Ask also that President Bush replace Satcher with someone who will not be a mouthpiece for Planned Parenthood's agenda.

#### **HEALTH & SCIENCE REPORT**

#### UNICEF—A HALLOWEEN TRICK

Halloween will shortly be upon us. Sometimes, in the midst of your doling out goodies, a small donation box will be extended. The explanation is often only a smile or at times, "Trick or treat for UNICEF!" You might assume that your contribution will be used to feed, clothe, shelter and educate the poor and disadvantaged children of the world via the United Nations International Children's Emergency Fund, known as UNICEF. The name was officially changed to the United Nations Children's Fund in 1953, but it is still referred to as UNICEF. Perhaps a large skull and crossbones should also appear on the donation box. Although this U.N. organization is famous for providing medical care, educational resources, clothing, shelter, food and water for the needy children of the world as stated in its charter, they also fund abortion, contraception (including abortifacients-IUD's and contraceptive pills) and sterilizations (including involuntary sterilization), and vaccine programs in which the anti-tetanus vaccine contained B-hCG, a sterilizing agent (given to women without informed consent). In the Philippines, 3.4 million people, mainly women aged 12-45 years, were vaccinated with this hormone-laced vaccine. This same anti-hCG hormone (which causes sterilization, miscarriages, birth defects and incurable auto-immune disorders) was also distributed in Mexico, Nicaragua, Tanzania and India. We did a report on this vaccine program some time ago. In 1995, the Catholic Women's League of the Philippines won a restraining order against this UNICEF and World Health Organization (WHO) anti-tetanus program. This program, under the guise of medical benefits, exploited and maimed millions of women surreptitiously.

All of UNICEF's involvement contained in our report is a matter of public record, since UNICEF is a government agency. They still continue to deny their involvement in antilife population-control activities. UNICEF is run by an Executive Board of U.N. representatives from 41 nations, all with their own agendas. Unfortunately, the 1960's overpopulation propaganda altered the course of UNICEF, which was formed in 1946 to care for the warravaged children of Europe and China. UNICEF actively joined International Planned Parenthood Federation (IPPF), World Health Organization (WHO), World Bank, United Nations Development Fund, UN. Fund for Population Activities, and the Population Council—all population control groups—to support contraceptive, abortion, and sterilization campaigns. Winifride Prestwich reports in her booklet "UNICEF: Guilty as Charged", that the US budget for UNICEF in fiscal year 1992 was \$55 million and \$60 million for FY 1993.

Several years ago we were challenged on this report with the information that even the Vatican donated to UNIŒF. They were giving a symbolic donation of \$2000. per year according to John Klink, advisor to the Holy See mission to the U.N., as reported in the National Catholic Register. But following a 1996 UNICEF Press Release in which UNICEF announced that it would be distributing "contraceptives and

drugs to terminate pregnancies to a million starving refugees in flight along the border between Rwanda and Zaire", the Holy See discontinued their funding of UNICEF. The Vatican decision is still in effect. A reading of the Holy See press release indicates how UNICEF was continually dishonest in its dialogue with the Vatican—as it is with everyone! The October 2000 National Catholic Register reported that Archbishop Lacalle of San Salvador, "from the pulpit, denounced a 170 page sex education booklet designed by UNICEF and El Salvador's Ministries of Health and Education for training adolescents on sexuality issues including contraception, homosexuality and abortion. The dignity of people, institutions such as marriage and the rights of the family are all practically demolished with this document." The Archbishop described illustrations in the manual intended for training 6,000 El Salvador youth to instruct their peers as "insinuating and grotesque". Sounds like a Planned Parenthood or Cornell Cooperative Extension Course to

In-depth scientific studies on population clearly indicate UNICEF involvement in population control in the 1970's, funding 80% of the oral contraceptives used in these programs. In later years, their funding increased and included IUD's, condoms, diaphragms, injectibles and spermicides. Population Report in 1977 listed UNICEF as supporting sterilization programs and developing the instrument kit for sterilization. They organized and expanded mobile sterilization units. In 1985, their project included the establishment of surgical contraceptive facilities. In 1987, they officially endorsed abortion. UNICEF really showed its depopulation agenda in 1992 when it increased its support for China's onechild family program from \$2 milion to almost \$5 million. This program includes pregnancy permission, late term abortions, after birth infanticide via injection or drowning, and involuntary sterilizations. UNICEF's 1997 edition of The State of the World's Children never referred to the "dying rooms" in China's orphanages, or "freezing rooms" where Ittle girls are tied or strapped to beds and toddler chairs and left to die, forced child labor or Chinese sweatshops where children are paid less than \$1 a month. But the report does commend China for passing legislation guaranteeing Chinese citizens the right to receive education. UNICEF considers China the most "baby friendly" nation in the world! If a Chinese woman has more than one child, she is punished by killing the child and being involuntarily sterilized. According to Population Research Institute, "a mother of two was beaten to death by population control authorities for refusing sterilization...U.S. law makes it completely illegal to give U.S. tax money to groups that use it for forced abortion or forced sterilization. And every year, despite that law, the United Nations gets \$25,000,000, from the U.S. Treasury and uses it in part to inflict the most vicious kind of 'population control' on Chinese women."

Clearly the UNICEF program that received the Nobel Prize in 1965 has departed from its original mandate to assist the needy children of the world, and the United Nations is complicit in anti-life population control atrocities. Please don't become a partner in these crimes against life this Halloween!


