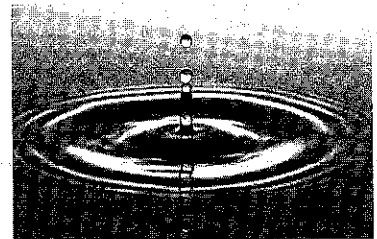

BACK TO SCHOOL - Planned Parenthood Gift Card.

School doors have opened again and who wants to welcome your children and grandchildren back to school? None other than Planned Parenthood in Suffolk County (www.plannedparenthood.org/hudsonpeconic) Planned Parenthood Hudson Peconic wants you to make it easier for children to visit them by purchasing "Back to School With PPHP Gift Certificates." The PPHP website promotion reads, "Say 'Don't forget to make that appointment!' with PPHP gift certificates for your students. Good for the HPV vaccine, which guards against cervical cancer, and for other PPHP products and services. \$25 each."

At the LI Coalition for Life street fair booth, after talking with the teens about abortion, respecting themselves and unborn babies, and reminding them that it would be better not to get in the situation of an unplanned pregnancy in the first place, one boy replied, Right - use a condom! and a girl said, Yeah, use Protection! So you know, unfortunately, they're getting Planned Parenthood's message - have sex if you want but be careful and if careful doesn't work, there's a way out. That same young lady had just pointed to the 7-1/2 month fetal model and said her friend recently aborted her unborn baby that age!

FIGHT BACK - TAKE ACTION!

Life Card: Instead of a Planned Parenthood gift certificate, hand out a card that makes a positive

statement. The LICL has "life cards" with pro-life phone numbers and information on fetal development. We can e-mail a copy of it to you to print or you can pick up some at an LICL general meeting (see notice above).

American Life League - STOPP International (www.stopp.org): Learn how to deal with Planned Parenthood's values neutral teen sexuality programs. A recent issue of the STOPP Report (www.all.org/article.php?id=12115) shows you Planned Parenthood's mentality - an evening gown made of condoms - part of an upstate NY Planned Parenthood group's event.

Freedom of Information Law: Send a letter to your school district asking the school to send you copies of correspondences, payments, speaker events, etc. between the school and Planned Parenthood (Hudson Peconic or Nassau County) so we can see if the organization is working in the schools. We can e-mail you a sample letter.

Be Aware: Check your children's health class information; ask about special speakers; check community papers for Planned Parenthood events; ask your local legislators if they have programs giving funds to Planned Parenthood.

FEDERAL LEGISLATION

2009 HEALTH CARE REFORM

If Health Care Reform legislation has not been finalized by now we urge you to, once again, contact (call, FAX, or E-mail) your Senators and Congressional Member.

ACTION-SAMPLE MESSAGE:

Dear ____: You are urged to oppose any health care reform unless abortion, euthanasia and funding of technologies that destroy human life are explicitly excluded. The language of this legislation must be specific and terms such as "medical procedure" and/or "clinical practices" must be defined and eliminated if these would allow abortion. In addition, "Conscience Protection" for health care providing institutions and workers must be included in the bill.

A REVIEW OF PARTY PLANKS

Some citizens have voted for their party down the line not realizing that their party's platform was pro-abortion. For example the 2008 Democratic Plank, Page 50, reads, "The Democratic Party strongly and unequivocally supports *Roe v. Wade* and a woman's right to choose a safe and legal abortion, regardless of ability to pay, and we oppose any and all efforts to weaken or undermine that right."

On the other hand, the 2008 Republican Party Plank, Page 52, reads: "...the unborn child has a fundamental individual right to life which cannot be infringed. We support a human life amendment to the Constitution, and we endorse legislation to make clear that the Fourteenth Amendment's protections apply to unborn children."

BLACK ABORTION OUT OF PROPORTION

African-American Father John Raphael, SSJ at the NRTL Convention 2009, told attendees that the pro-life community and the African-American community have much in common regarding the respect for human life but have not connected significantly. Fr. Raphael believes that the black population needs to be convinced that the life issue is so important that they would insist that whoever asks for their vote should be pro-life.

The black community makes up for 13% of the over three hundred million U.S. population but they have over 37% of the annual abortions. Fr. Raphael urged a strong bridge of communication between the pro-life and the black communities to educate on the importance of protecting the lives of unborn black children.

NEW YORK STATE LEGISLATION

THE HEALTHY TEENS ACT – S.3836/A.1806-A passed in the NYS

Assembly on 6/17/09 by a vote of 129 to 16. The only Nassau/Suffolk Assembly Member voting against is Fitzpatrick. Those voting to pass (a pro-abortion vote) are: Alessi, Alfano, Barra, Boyle, Conte, Eddington, Englebright, Fields, Hooper, Lavine, McDonough, McKeivitt, Raia, Ramos, Saladino, Schimel, Sweeney, Thiele, Walker and Weisenberg.

The Senate has yet to vote. Fearing a quick vote in a "Special Session" between now and 12/31 we urge you to go on record as opposing this bill by contacting the Governor and your NYS Senator.

ACTION-SAMPLE MESSAGE:

You are urged to vote against the "Healthy Teens Act" A.1806-A.. This bill would establish a new sex education program in the state enabling school districts and organizations such as Planned Parenthood to access a new stream of state funds to teach "comprehensive sex education."

The Making of Biased News Reporters

Biased news reporters are not born - they're developed. Here's one example in the making. Paul Schreiber High School (Port Washington) has a newspaper that accepts paid advertisements. The Long Island Coalition for Life has attempted to place ads in high school and college newspapers in the past, with varying degrees of success.

Timeline Overview:

October 2008: Pro-lifer alerts LICL that Schreiber Times carried a Planned Parenthood Inc. ad.

November 2008: LICL submits an ad to Schreiber Times. Ad isn't published.

March 2009: After several attempts by LICL to contact newspaper's student staff go unanswered, LICL contacts one of the paper's faculty advisors. The managing editor then calls LICL and explains why ad was rejected.

-- Business manager tells LICL to "please make sure that the ads you send us in the future are more neutral"

-- LICL submits a second ad (shown top right)

-- Ad not published.

April 2009: Repeated attempts to contact student staff go unanswered until LICL calls the same faculty advisor.

-- Managing editor sends LICL an e-mail explaining why news staff rejected LICL ad again; e-mail is signed by editor in chief, managing editor and two faculty co-advisors

May 2009: LICL responds to paper's censorship and sends letter to the 4 people who signed the April e-mail, and the high school principal, Port Washington superintendent of schools, and Board of Education president. No reply to date (9/8/2009).

Reasons one or both ads were rejected:

-- "creates an uncomfortable situation for students who might be or might have been in this situation"

-- "not suitable for a high school audience"

-- "does not advertise a product, event or service, but a political stance"

This is censorship, plain and simple. The ad is not political and the LICL replied to the students that the LICL finds "it very disconcerting that your faculty co-advisors ... would allow you to misrepresent our ad in such a manner."

The LICL further defended the ad: "The LICL 'product,' if you will, is saving lives and, in the process, keeping those whose lives are touched by that child (mother, father, grandparents, siblings, friends, etc.) from what often becomes a life of pain and regret over

the abortion decision. You obviously agree with the latter to some extent because you rejected both ads I submitted on the grounds that they may make students (faculty and staff, too?) uncomfortable who've been there done that. If something were bad, wouldn't you want to prevent it from happening to someone else? Your compassion for a student who has already lost a child through abortion fails the veracity test if you are willing to let others make the same decision without the benefit of an alternative point of view...."

The LICL argued that **ads, by their very nature, are not neutral!** How can ads discussing abortion be inappropriate for high school students, too many of whom are sexually active and having abortions?

The LICL pointed out to the students: "You may be too misinformed by the world around you to understand your decisions, but I suggest that the co-faculty advisors of the Schreiber Times know what the newspaper staff's intellectually dishonest rejection rhetoric did - you and they silenced the pro-life point of view. In so doing you may have left the life of an unborn child and his/her mother at risk who might otherwise have made a life-affirming decision."

ACTION: If your local high school newspaper has ads, consider placing a pro-life ad (display or classified) in the paper. The LI Coalition for Life will help with prepared ads. Ask a respect life committee or other local pro-life resource to fund the ad. Contact the LICL for further information: 631-243-1435.
